2024-2025 Series General Orders No. 10 April 2025

## **IMPORTANT: REPORT OF ELECTION FORM**

National Headquarters has mailed all Post Quartermasters a packet, including the 2025-2026 Report of Election Form with instructions on submitting their report online using the Online Membership System (OMS). A blank Post Election Report can also be found in the "Document Repository" section on the Online Membership System (OMS). Also included in that packet is information on registering your Post for the National Convention and a room reservation form. The 126<sup>th</sup> VFW National Convention will be held August 9-13, 2025, in Columbus, OH. Post Election Reports must be submitted to the National Headquarters following the post-election of officers in April and no later than June 1st. We encourage all the Post Quartermasters to use the Online Election Report filing process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to Department Headquarters.

# **REMINDER: STATE BYLAW CHANGES**

Resolutions affecting the Bylaws of the Department must be received in State

Headquarters by no later than May 15, 2025, so they can be circulated to all Posts

within the prescribed time before the State Convention. Resolutions affecting

Department Bylaws received after that date cannot be considered at this State

Convention. ALL RESOLUTIONS MUST BE SUBMITTED IN PROPER FORM.

Any Resolutions received that are not in proper form will be returned for correction.

NOTE: For your resolution to be included in the State Convention Resolutions Book, it

must be received at State Headquarters no later than May 15, 2025.

## **NOMINATION, ELECTION, AND INSTALLATION OF OFFICERS**

Section 216 and 416 of the National Bylaws is quoted below for your information and necessary action. Please note paragraph c.

#### Sec. 216 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The Post shall elect the Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, and three (3) Trustees.
- (b) The Commander shall appoint an Adjutant, Chaplain, and Service Officer.
- (c) The Post may elect, or the Post Commander may appoint a Judge Advocate, Surgeon, Officer of the Day, and/or Guard if required by Post Bylaws.
- (d) The Post Commander may appoint such other chairmen and committees as deemed necessary to conduct the affairs of the Post or as may be required by Post Bylaws.

Several posts have bylaws stating that the Post Officers shall be elected in accordance with the National Bylaws or are silent on the election of officers as the National Bylaws have precedence. With the change to 216c, they should review their bylaws and decide if they wish the positions in 216c to be elected or appointed. Part 416 of the National Bylaws is quoted below for your information and necessary action. Please note paragraph c.

#### Sec. 416 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The elected officers of each District shall consist of a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, and three (3) Trustees.
- (b) The Commander shall appoint an Adjutant, Chaplain, Service Officer and an Inspector
- (c) The District may elect or the District Commander may appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if required by the District Bylaws
- (d) The District Commander may appoint other chairmen and committees as deemed necessary to conduct the district's affairs or as may be required by District Bylaws. Paragraph c allows Districts to choose between electing or appointing the listed officers. Should the District wish to appoint a Judge Advocate, Surgeon, Chief of Staff, or Officer of the Day, they need to have this reflected in their bylaws.

#### Section 417 of the Manual of Procedure

Sec. 417 - Nomination, Election, Installation, and Term of Office. Order of nominations and elections.

The order of nominations and elections shall be Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Judge Advocate, Surgeon, and Trustee(s).

**Nomination:** Any member may be nominated and elected although not present at the meeting. A member nominating an absentee for any office shall have presented to the Adjutant, in writing, the consent of the nominated member before the closing of nominations. Any nominee shall have the opportunity to decline the nomination for the office to which they have been nominated before nominations are closed. Nominations shall remain open until the District Convention is ready to vote.

**Election:** In balloting for District officers, a majority of all the votes cast shall be necessary for election. If there is no election on the first ballot, the name of the comrade receiving the lowest number of votes shall be dropped and so on in successive ballots until an election is made.

**Challenging Election Results:** If irregularities are claimed in the election to any office, the challenge must be made before the close of the meeting.

Installation: District officers shall be installed before the meeting adjournment at which elected. The installation shall be conducted by a member in good standing who holds or has held an office equal to or higher than District Commander. The District Commander-elect shall select the installing officer. An officer who may be absent for good and sufficient reason or cause shall be installed at any succeeding regular or special meeting of a unit of the organization within sixty (60) days of the date of installation. If not then installed, the office will automatically become vacant.

**Term of Office:** Officers shall be elected for a term of one (1) year except that three trustees shall initially be elected for a term of one (1), two (2), and three (3) years.

District officers shall take office upon the conformation of election and installation of the Department Commander by the Department Convention.

#### **INSTALLING OFFICERS**

Installing officers will see that the provisions of Section 216 of the National Bylaws and the Manual of Procedure are properly carried out and that all officers are members in good standing and qualified to hold office before installing Post officers for the current year. Post officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and adequately reviewed. Post Election Reports must be submitted to the National Headquarters following the post-election of officers in April and no later than June 1. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to the Department Headquarters.

#### SPECIAL NOTICE REGARDING DISTRICT CONVENTIONS

The District Convention is held for the purpose of electing your officers for the upcoming administrative year. Any member who is not a member of the District Convention (Refer to Section 404 of the National Bylaws) may attend the Convention. However, they shall have no voice in business discussions unless requested by the Commander and shall have no voting privileges. The Commander shall recognize those on official business for the conduct of business. (Article IV, Sec. 403 – Regular, Special and Committee Meetings; Convention; Quorum; Authorized Attendees).

# PROOF OF ELIGIBILITY REQUIRED FOR ALL ELECTED AND APPOINTED OFFICERS

Officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and adequately reviewed. Proof of eligibility shall be open to review by the District Commander, Adjutant, and Quartermaster before installation to office. In the event an elected or appointed officer fails to submit proof of eligibility within thirty

(30) days of election or appointment, any right of the officer to hold the office shall be forfeited, the office declared vacant and the eligibility qualifications of such officer shall be questioned in accordance with the provisions of Section 108 of the National By-Laws. Proof of Eligibility for District Commanders, District Senior Vice Commanders, and District Junior Vice Commanders <u>MUST</u> be furnished to the State Adjutant within thirty (30) days of Election.

#### **COMMANDERS-ELECT AT ALL LEVELS**

Your attention is directed to the fact that the State Commander does NOT ASSIGN a Past Post, District, County Council Commander, or a State Officer to be an Installing Officer. This is something that is between you and the Officer you choose.

#### REMINDER - POST/DISTRICT OFFICER CHANGES OR CORRECTIONS

Please note that Post or District Officer changes must be reported to State Headquarters immediately. Changes in addresses, phone numbers, and e-mail addresses should also be reported immediately—even if they are made on the Online Membership System (OMS). These changes are not always transmitted to State Headquarters; please help us keep our records current.

# **ELECTION OF POST DELEGATES**

Congressional Charter, Bylaws, Manual of Procedure and Ritual
Article II - Posts, Section 217

#### Nomination, Election, Installation, and Term of Office of Post Officers

Post officers shall be elected in April. Balloting for Post Officers may be conducted by open vote or written secret ballot (handwritten or printed) at a regular Post meeting, or, if required by Post Bylaws or authorized by Post vote before the opening of nominations, by a poll system. Absentee ballots and proxy votes are prohibited. A majority vote of all votes cast, except where otherwise designated, shall be necessary to elect. If there is no election on the first ballot, the name of the comrade receiving the lowest number of votes shall be dropped, and so on, in successive ballots until an

election is made.

#### Article II - Post, Section 222

#### Delegates, District Conventions & Meetings, Department and National Conventions

Delegates and alternates for the District Convention and Meetings, Department and National Conventions shall be elected at an April meeting. Delegate Strength will be based on members in good standing as of March 31<sup>st</sup>. Delegates shall not be recognized at the National Convention unless they personally register their completed delegate card with the National Credentials Committee.

#### **SPRING POPPY DISTRIBUTION**

Commanders on all levels should be organizing their 2025 Memorial Day Poppy Distribution. Promotional material is available from the VFW Store Catalog. Every Post is urged to order and distribute Buddy Poppies; poppies can be ordered and paid for from our website — <a href="www.vfwil.org">www.vfwil.org</a>, using the "donate now" button. A poppy order form can be printed out and mailed with a check to State Headquarters. It is under the "resources" and then go to "reports and forms". They are available in multiples of 500. All other accessories, such as caps, aprons, cans, etc., can be ordered directly from the VFW Store at National Headquarters.

# **VOICE OF DEMOCRACY PARADE OF WINNERS**

Every year, nearly 26,400 of our nation's youth compete in the VFW's Voice of Democracy and Patriot's Pen audio essay competitions for their chance to win a portion of more than \$1.4 million in college scholarships and awards. The competitions culminate with the Parade of Winners event to celebrate and recognize the contests' top national winners.

Congratulations to our Patriots Pen and Voice of Democracy winners from Illinois.

Our Patriots Pen winner, Georgia Roscoe, sponsored by Post 2245, District 5, finished 22nd Place at the National competition and received \$1,000.

Our Voice of Democracy winner Joseph Martinez, sponsored by Post 4724, District 9, finished 30<sup>th</sup> Place at the National competition and received \$2,000.

Themes for 2025-2026 Patriot's Pen and Voice of Democracy have been announced. Information is on the vfwil.org web page and attached to these General Orders.

# 2025 DISTRICT COMMANDER-ELECT TRAINING

Once District Elections are held, an invitation will be sent to newly elected District Commanders for 2025-2026. Department Headquarters will provide rooming accommodations for 4 nights (Wednesday-Sunday) for incoming District Commanders at the Wyndham Springfield City Centre, 700 E. Adams Street in Springfield. Mandatory District Commander training will be held on Thursday, June 5th, at 8 am in BOS Center.

PLEASE NOTE: District Commanders-Elect should be present during the Council of Administration Meeting on June 6th, 2025. The dress code is a suit, coat, tie, and cap to

have your photograph taken. They must also be present on Saturday, June 7th, 2025, during the installation of officers!

On Sunday, June 8th, there will be a brief Council of Administration meeting at 9 am to pass an interim budget until the next meeting in August.

#### **ATTENTION POST COMMANDERS**

<u>Under the Department of Illinois Veterans of Foreign Wars Bylaws, Article V - Convention Section 8:</u>

"Each Post shall register, in advance or at the Convention, at least one delegate to the Department Convention by payment of the advance registration fee in effect for such Convention, which fee shall entitle the Post to a packet of convention information and materials. Post failing to comply with this requirement shall be considered delinquent and in arrears.

### **STATE CONVENTION REGISTRATION**

These general orders include the advanced registration form for the State Convention. Delegates can also register online at www.vfwil.org. The registration fee is \$20.00 until May 31, 2025, and \$22.00 afterward. After the proper registration fee has been paid, registration confirmation letters will be mailed to registrants. Registrants must present this confirmation when they check in at the convention registration desk at the BOS Convention Center.

**REMINDER:** Delegates <u>will not</u> be allowed to vote until such issues have been resolved if the Post is in arrears for supplies, poppies, or any financial obligation to the Department. The Post must be bonded and passed inspection, have an election report on file with the Department and National Headquarters for the ensuing year, and have all audits approved, including the March 31, 2025, audit.

The convention's delegate strength is based on one delegate and one alternate delegate per thirty members or a fraction thereof.

# **NOMINATIONS FOR AWARDS AND CITATIONS**

We are accepting nominees to be considered by our Convention Awards & Citations Committee for our State Convention. The deadline for award nominations for our State Convention is April 30, 2025, for the following categories:

Outstanding Legislator of the Year

- Outstanding Patriotism of the Year
- Outstanding Governmental Service of the Year
- Clergy of the Year
- News Media Professional of the Year
- Outstanding Citizen of the Year
- JROTC Cadet of the Year
- Employer of the Year
- Life Saving Award

There is no form to fill out. Just write down the name, address, sponsoring post number, contact person, and the reason why you feel this individual deserves to be recognized. THE DEADLINE DATE IS April 30th, 2025.

#### COMMUNITY ACTIVITIES RECORD BOOK

Community service, as defined by the National Community Service Trust Act, "encompasses any human act serving the common good; in the interest of the community." Community service is further defined as "a service that is performed for the benefit of the public or its institutions."

Annually, we ask all VFW Posts to submit record books detailing their Community Service Projects. We encourage Posts to gather pictures, newspaper clippings, letters, receipts, etc., and compile this vital record of their activities in their community. We receive fewer and fewer entries each year for judging; ask for volunteers in your Post to assemble this essential part of your Post's history. Please get in touch with State Headquarters if you have any questions.

When the Community Activity Record Books are submitted for judging, they must have the official entry form attached to the inside front cover. The Official Entry Form is in the Commander's Leadership Manual. At the end of these orders, your record book must be at State Headquarters by May 2, 2025, for judging on May 6, 2025.

# **ALL-STATE POST AWARDS**

The All-State Program runs through June 15<sup>th</sup>, 2025. To receive All-State Awards at the State Convention, the deadline to complete All-State Criteria is April 30, 2025. All State Post Commanders will receive an All State Post Commanders Cap and Distinguished Service lapel pin. All-State Post Quartermasters can purchase an All-State Post Quartermaster Cap and receive a Distinguished Service lapel pin. All-State Post Members have the option to purchase an All-State Team Member cap. The 2024-2025 All-State Program is designed to recognize exceptional leadership and teamwork in Membership, overall Post/District development, and VFW Programs. If a Post qualifies as "All-State", ALL Post members will be recognized for this achievement

because THEY ARE A TEAM. The All-state Team of Post Commanders and Post Quartermasters will be made up of Post who achieves:

- Membership greater than 101%
- Post must hold 1 membership drive/events and submit report to Program
   Reporting Dashboard
- Post must be 100% reported on the Department Programs Reporting Dashboard
- Post must have submitted all 4 quarterly Trustees Audits and audits were approved
- The post must be in compliance with all questions on the National and Department Inspection Sheets.
- Post must order at least 3 poppies per member with a minimum of 1,000 poppies
- Each post must have one nomination for each of the programs of Patriot's Pen,
   Voice of Democracy, and Teacher of the Year or Employer of the Year submitted
   to the district for judging. Donations to Voice of Democracy and Patriots Pen as
   stated in this manual will be accepted if a Post does not have a nomination
- Post must have one nomination in the following programs: Teacher of the Year or Public Safety (police, fire, EMT, dispatcher, EOD). Donations to any of these programs DO NOT receive credit towards All State Awards
- Post must have representation at all properly called District Conventions and meetings
- Post must have representation at any of the Commanders Calls (Roll Call will be taken)
- The post must make a \$50 donation to the Service Office Support Program (SOS). This is separate from the Red, White, and Blue Program donations

# **ALL-STATE DISTRICT CRITERIA**

All State District Commanders will receive an All-State District Commander's Cap and a Distinguished Service Lapel Pin. There will be no limits to the number of Districts that can achieve All-State status. The criteria are as follows:

- Membership greater than 101%
- Districts must have 100% of Posts inspected, and the State inspector must clear the inspections by April 30, 2025
- Districts must hold a minimum of one School of Instruction and submit a report to State Headquarters
- District must hold or participate in 1 membership drive/events and submit report to Programs reporting dashboard
- Districts must submit 1 of each of the following to Department Headquarters for judging:
  - Patriots Pen
  - Voice of Democracy
  - Teacher of the Year
  - Public Safety of the Year (police, fire, EMT, dispatcher, EOD)
- The district must forward a record of the Roll Call of Officers and Posts of each District meeting to State Headquarters.

# **ALL-AMERICAN POST LEADERSHIP CRITERIA**

- Membership greater than 102%
- Post Election Report must be submitted to National Headquarters
- Meet all of the following Program Participation Criteria by January 31, 2025:
- Voice of Democracy Minimum of one entry advanced to District judging
- Patriots Pen minimum of one entry advanced to District judging
- Donate to Veterans & Military Support Programs Services (Minimum of \$125)
- A Post must submit a community service report quarterly to their department for submission to the All-American Dashboard. The quarters are July-Sept, Oct-Dec, Jan-March, and April-June. One of these community service activities must be for the VFW Day of Service
- Buddy Poppy Purchase a minimum of 500 Buddy Poppies

# **ALL-AMERICAN DISTRICT CRITERIA**

- Membership greater than 102%
- District Election Report must be submitted to National Headquarters
- Meet all of the following Program Participation Criteria by January 31, 2025:
  - Voice of Democracy Minimum of one entry advanced to District judging
  - Patriots Pen minimum of one entry advanced to Department judging

# 126<sup>th</sup> VFW NATIONAL CONVENTION

Columbus, OH, is the host city for the 126th VFW and 111th Auxiliary National Conventions, which will be held August 9- 13, 2025. Convention housing opened on March 17, 2025. Hotel reservations can be booked on the VFW website, <a href="https://www.vfw.org">www.vfw.org</a>.

# VFW NATIONAL CONVENTION HOUSING

The 126th National Convention housing opened on Monday, March 17, 2025. Housing reservation information will be located on the convention website, accessed through the main VFW website at vfw.org/convention. The convention website will also have general convention information, including the registration form and links to other convention-related information for Columbus, OH – August 9-13, 2025, and a tentative agenda.

# NATIONAL CONVENTION REGISTRATION

Section 222 of the Manual of Procedure states that each Post will pay, in advance, a National Convention Registration Fee of \$25 - which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Please note that each additional delegate attending the National Convention must pay an additional \$10 delegate fee. Information on delegate registration will be available at a later date.

#### **NEW CENTURY RAFFLE**

The New Century Raffle has officially started and will run through June 30, 2025. The tickets are just \$10.00 each. Each ticket entitles you to a weekly drawing of \$100 from July 1, 2025, to June 30, 2025. 

# What is the Voice of Democracy Program?

Since 1947, the Voice of Democracy has been the Veterans of Foreign Wars' (VFW's) premier scholarship program. Each year, nearly 26,000 high school students compete for more than \$2 million in scholarships and incentives. Students compete by writing and recording an audio essay on an annual patriotic theme. This year's theme is, "How Are You Showing Patriotism and Support for Our Country?"

#### Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, state and national level. National winners will be notified of their scholarship & placement.

#### The Rules

#### Who can enter?

The Voice of Democracy is open to students in grades 9-12 by the Oct. 31 deadline who are enrolled in a public, private or parochial high school or home study program in the United States, its territories and possessions; or dependents of U.S. military or civilian personnel in overseas schools. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application for which has not been denied) and intend to become a U.S. citizen at the earliest opportunity allowed by law. Foreign exchange students, students age 20 or over, GED or Adult Education Students are ineligible.

#### What do I need to enter?

Record your original 3-5 minute (+ or – 5 second max.) audio essay on a flash drive, or other electronic device. You will submit the recording, typed essay and this completed entry form. Provide these items to your school/group competition or VFW Post for judging. In addition you can submit your emailed entry form, essay, and audio file to the VFW Post upon approval. You must be the sole author of your essay. Inappropriate use of ChatGPT or or other AI tools is not allowed. The recording must be in your own voice and in English. Hearing/speech impaired students should email the Voice of Democracy National Office at youthscholarships@vfw.org for special instructions. No music, singing, poetry or sound effects are allowed. The body of the essay must not

identify you in any way, (including, but not limited to your name, school, city, state, race or national origin) although the recording and typed essay should be labeled with your name, to show ownership.

#### Where Do I Submit My Entry?

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post. Entries sent to VFW National will be returned. One winner for every 15 entries from each Post advances to District and one District winner advances to the state (Department) competition. # What Is the Deadline for My Entry?

All entries competing at the Post level must be in the hands of that VFW Post by midnight, Oct. 31, 2025. It is the responsibility of the student to meet this deadline by submitting their entry to the proper location by ensuring it is a participating Post.

# What Are the Judging Criteria?

#### Originality is worth 30 points:

Treatment of the theme should show imagination and human interest.

#### Content is worth 35 points:

Clearly express your ideas in an organized manner. Fully develop your theme and use transitions to move smoothly from one idea to another.

#### Delivery is worth 35 points:

Speak in a clear and credible manner.

# What is the Patriot's Pen Program?

Conducted nationwide, this VFW-sponsored youth essay competition gives students an opportunity to write essays expressing their views on an annual patriotic theme.

We invite you to join the more than 60,000 students who participated last year in this contest.

#### Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, state and national level. Department (state) winners receive a portion of \$55,000 in national awards. National winners will receive at least \$500. The first place national award is currently \$5,000.

The Internal Revenue Service requires a recipient awarded more than \$599 be given Form 1099 identifying the proceeds as taxable income. This may require the winner to provide their social security number.

#### **How Does the Contest Work?**

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post.

The contest consists of four levels. The first level (entry) is sponsored by VFW Posts. Post winners advance, one for every 15 entries, to the VFW District (regional) level where the one first place winner is advanced to the VFW Department (state) level. The first place winner at the Department level is then advanced into the VFW national competition.

#### Who Can Enter?

Patriot's Pen is open to 6th, 7th and 8th-grade students enrolled by the Oct. 31 deadline in public, private or parochial schools in the U.S., its territories or its possessions; or dependents of U.S. military or civilian personnel in overseas schools. Homeschooled students also are eligible. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application which has not been denied) and intend to become a U.S. citizen at the earliest opportunity allowed by law. (Foreign exchange students are ineligible.)

#### How Do I Get Started?

- Ask a teacher or youth group/club adult leader to supervise the Patriot's Pen writing contest.
- Contact a participating VFW Post and indicate your interest in participating.

- Establish a contact person who is a member of that VFW Post or its VFW Auxiliary.
- Make sure that your essay is submitted to the VFW Post before the contest deadline of Oct. 31, 2025. You can submit your essay and entry form by email upon the Post's approval. Entries sent to the VFW National Headquarters directly will be returned.

#### How Am I Judged?

#### Knowledge of the theme is worth 30 points:

You must show a thorough knowledge of the theme in your work. Demonstrate you have researched the issue extensively.

#### Theme development is worth 35 points:

Answer all relevant facts about the theme such as the who, what, where, when and why. Relate the theme to your own experiences.

#### Clarity of ideas is worth 35 points:

Write your essay in an easy-to-understand format. Leave your reader with a clear understanding of your explanation of the theme.

#### What Is the Theme?

The VFW Commander-in-Chief chooses the year's theme.

The 2025-2026 theme is:

"How Are You Showing Patriotism And Support For Our Country?"

To qualify, all entries must be submitted to a sponsoring VFW Post by midnight Oct. 31, 2025.



#### Comrades,

As we shift into the final months of this fiscal year with district conventions, elections, and program deadlines, we need to continue to push for excellence.

From the health and wellness table, which is something our membership should always strive to excel at. The main goal this year was to push Posts, with a home, to purchase an AED machine to have as a proactive measure. Remember, sudden cardiac arrests result in a death every 2 minutes. The most expense savvy way to get an AED machine is through a grant. This can be done on your own or you can use **AEDgrants.com** which I have found to be a possible tool for acquiring these machines.

Now for the hospital/VAVS (veterans affairs voluntary service) table. We are an organization that is spearheaded by veterans' assistance, that is why it is one of our 5 program pillars. One of the main pieces of the veteran's assistance pillar is "support of VA hospital or state veterans' home," which is our IDVA veterans' homes throughout the state. Some of our Posts that are off the beaten path may not have one of these two types of facilities in their immediate area, so the program also expands to CBOC's (community-based outpatient clinics), nursing homes, or regional hospitals in general.

As of todays date 3-22-25, here is each districts reporting outlook on the "support of VA hospital - state veterans' home":

Each year, posts and districts lose valuable credit for their effort because nobody takes the time to report.

Convention awards will be determined based on reports received by April 30th, 2025.

Awards will be given to the "top post" in each membership category in the form of a plaque.

All districts who achieve 100% in post participation in the hospital/VAVS program by April 30th, 2025, will be awarded \$50 to be used in the continuation of their hospital/VAVS program.
