The VFW meetings will be held in the BOS Center at 1 Convention Center Plaza Springfield, IL 62701, which is located conveniently adjacent to both hotels. The VFW Auxiliary meetings will be held in the President Abe Lincoln Double Tree Hotel. ### STATE CONVENTION REGISTRATION

Included in these General Orders is the Advance Registration Form for the State Convention. Delegates can also be registered online by going to <a href="www.vfwil.org">www.vfwil.org</a>. The registration fee is \$20.00 until <a href="May 31, 2024">May 31, 2024</a>, and is \$22.00 after <a href="May 31, 2024">May 31, 2024</a>. Letters of registration confirmation will be mailed to registrants after the proper registration fee has been paid. Registrants will be required to present this confirmation when they check in at the convention registration desk at the BOS Convention Center.

**REMINDER:** Delegates <u>will not</u> be allowed to vote until such issues have been resolved if the Post is in arrears for supplies, poppies or any sort of financial obligation to the Department. The Post must be bonded, inspected, have an election report on file with Department and National Headquarters for the ensuing year, and all audits **including** the March 31, 2024 audit must be submitted and approved.

Delegate strength to the convention is based on one delegate and one alternate delegate per thirty members or fraction thereof.

### 2024 CONVENTION RAFFLE AND PURPLE HEART TICKETS

Tickets for the 2024 Purple Heart and Convention raffle went out in the December issue of the Illinois VFW newspaper. Included were 2 sheets of 5 tickets (\$20 each) and two Purple Heart tickets (\$5 each). Winners will be randomly selected at our State Convention in June, for the following: \$10,000 grand prize, \$3,000 second prize, \$2,000 third prize, \$500 awarded to fourth through tenth place winners. ### **COMMANDERS SPRING MEMBERSHIP CHALLENGE**

We are behind on our recruiting goals for this time in the program year. Recruiting is a grassroots effort from the members to ask people to join the VFW or to reinstate their membership in the VFW. We still have a chance to reach our recruiting goals for the year but it is going to take some serious effort. Every member is asked to get at least one new or reinstated member. We have seen some that have far exceeded that goal and are doing much more. Every member is a recruiter.

### RECRUITER CHALLENGE.

We are going to reward the top recruiter for this spring membership challenge.

This membership challenge will run from Feb 1, 2024 to April 30, 2024. The VFW member that recruits the most new or reinstated members during the contest period will receive a specially engraved Henry 22Ir Golden Boy Rifle.

The Top Recruiter must be listed as the recruiter on a minimum of 10 applications for new or reinstated members to qualify for the rifle. (Must have FOID card to claim rifle)

If the Top Recruiter has less than 10 new or reinstated members, then they will receive \$300 cash prize.

Every VFW Member that recruits at least 1 new or reinstated member will be placed into a random drawing for other prizes.

### **ALL-STATE POST AWARDS**

The 2023-2024 Membership Program is designed to recognize exceptional leadership and teamwork, not only in Membership but in overall Post/District development and VFW Programs. If a Post qualifies to be "All State" all Post members will be recognized for this achievement because they are a team.

The 2023-2024 All-State Post Criteria is as follows:

Membership greater than 102%

- Posts must hold 2 membership drives/events and submit report to Program Reporting
   Dashboard
- Posts must be 100% reported on the Department Programs Reporting Dashboard.
- Posts must have submitted all 4 quarterly Trustees Audits and audits were approved.
- Posts must be in compliance with all questions on the National and Department Inspection Sheets (for example: a post that is not incorporated shall not be eligible until proof is provided that they are in compliance)
- Posts must order at least 3 poppies per member with a minimum of 1,000 poppies.
- Posts must have one nomination for each of the programs of Patriot's Pen, Voice of Democracy, and Teacher of the Year or Employer of the Year submitted to District for judging.

Donations to Voice of Democracy and Patriot's Pen as stated in this manual will be accepted if a Post does not have a nomination.

- Posts must have representation at all properly called District Conventions or meetings.
- Posts must have representation at a minimum of 1 Commanders Calls. (Roll Call will be taken)
- Posts must make a \$50 donation to the Service Office Support Program (SOS) this is separate from the Red, White, and Blue Program donations.
- New Posts need a minimum of 50 members to achieve-All State

The All-State Program runs through June 15, 2024. To receive All-State Awards at the State Convention, the deadline for completion of All-State criteria is April 30, 2024. There will be no limits on the number of Posts that can achieve All-State status.

All-State Post Commanders will receive an All-State Commander cap and distinguished service lapel pin. All-State Quartermasters may purchase an All-State Post Quartermaster cap and will receive a distinguished service lapel pin. All-State Post Members may purchase an All-Sate Post Member cap.

### **ALL-STATE DISTRICT CRITERIA**

- Membership greater than 102%
- Districts must have 100% of Posts inspected and the inspections must be cleared by the state inspector by April 30, 2024
- Districts must hold a minimum of one School of Instruction and submit a report to State Headquarters.
- District must hold or participate in 2 membership drive/event and submit report to Programs Reporting Dashboard.
- Districts must submit 1 of each of the following to Department Headquarters for judging:
- o Patriot's Pen
- Voice of Democracy
- o Teacher of the Year
- Employer of the Year
- Districts must forward a record of the Roll Call of Officers and Posts of each
   District Meeting to State Headquarters.

### **ALL AMERICAN POST CRITERIA**

- Membership greater than 102%
- Must conduct 2 membership recruiting events, submit reports through All-American
   Dashboard
- Post Election Report must be submitted to National
- Posts must meet all of the following Program Participation Criteria:
  - Voice of Democracy- minimum of one entry advanced to District judging.
     (Overseas Posts can donate \$100 to National in lieu of entry).
  - Patriots Pen-minimum of one entry advanced to District judging.

(Overseas Posts can donate \$100 to National in lieu of entry).

- Hold a fundraiser with the proceeds going to Veterans and Military Support
   Program Services. Minimum of \$100
- National Citizenship Education Teachers Award one entry advanced to Department judging (Overseas Post can donate \$100 to National in Lieu of entry)
- A Post must submit a community service report to their department for submission to the All-American Dashboard. The quarters are July-September, October-December, January-March and April through June
- Buddy Poppy Purchase 3 per member in the Post

### **INCORPORATION OF UNITS**

Your attention is directed to the following excerpts from Section 708 of the Bylaws and Manual of Procedure.

<u>BYLAW</u> - Posts, Districts, and Departments of the Veterans of Foreign Wars of the United States <u>shall be incorporated</u> within the state where they are located <u>as prescribed in the Manual of Procedure.</u>

MANUAL OF PROCEDURE - Proposed Articles of Incorporation and amendments thereto shall be forwarded to the Department Commander for review through channels to the Adjutant General for review by the Commander-in-Chief for compliance with this Section. Articles shall not be filed with the appropriate state officials until review has been completed. No proposed Articles or amendments thereto shall be reviewed by the Commander-in-Chief unless so recommended by the Department Commander.

### **MEMBERSHIP**

Quartermasters are reminded and encouraged to go to the Online Membership System (OMS) and click on the reports listing members that are 30 and 60 days from expiration. All officers are encouraged to make every effort to contact these continuous members and ask them if they are ready to renew their membership or become Life Members prior to their expiration date. Remember that the Post Relief Fund can help pay the dues of a member that wishes to remain a member but is financially unable to pay his/her dues.

### **BONDS**

Posts not bonded with the State of Illinois VFW are required to provide State

Headquarters with a copy of the Surety Bond with a Fidelity Company approved by your

Post membership.

### SEC. 219 - RELIEF FUND

Section 219 of the National by-laws is quoted below:

A relief fund will be established and maintained by the Posts. In this fund shall be credited the net proceeds of the distribution of Buddy Poppies and such other monies as may be solicited or donated for veteran's relief purposes. Expenditures from the relief fund shall be as prescribed in Section 219 of the Manual of Procedure.

Any audit submitted to Department Headquarters that does not indicate the Post is maintaining a Relief Fund will be rejected and returned for correction.

### **ILLINOIS VETERAN'S LOBBY DAY**

This year, the IL VFW has invited other IL veterans' service organizations to join us for a Veteran's Lobby Day at the State Capitol in Springfield, IL on March 13, 2024. Any VFW member that wishes to participate is asked to plan on being in Springfield that day. The day will start out with a meeting of all the participants for coffee and donuts. This will be a chance for everyone to discuss the planned visits for the day and the talking points that will be discussed with members of the IL General Assembly. We will then break up into teams and visit the offices of the State Representatives and State Senators to talk about the veteran's issues in IL. The day will conclude with a social hour to discuss the day's results.

All the talking points and bill info will be provided, so no lobby experience is necessary. This has been successfully done at the federal level to discuss veteran's issue with the Members of Congress and we plan to use the concept to let our State Legislators know what veteran's issues we think our important for IL and for our members. Plan to attend and make our first Veteran's Lobby Day a success.

### **DEPARTMENT BY-LAW CHANGES**

Resolutions having effect on the By-Laws of the Department must be submitted in **proper form** and received by State Headquarters by no later than **April 30, 2024\*\*** so that the resolutions can be circulated to all Posts within the proper time prior to the State Convention. Resolutions affecting the Department By-Laws received after that date cannot be considered at the convention. **If you have questions regarding proper form please contact State Headquarters.** 

### **COMMUNITY ACTIVITIES RECORDBOOK**

Community service, as defined by the National Community Service Trust Act "encompasses any human act serving the common good; in the interest of the community." Elsewhere, community service is further defined as "a service that is performed for the benefit of the public or its institutions."

Annually we ask all VFW Posts to submit record books detailing their Community Service Projects. We encourage Posts to gather pictures, newspaper clippings, letters, receipts, etc and compile this important record of your Post's activities in your community. We are receiving fewer and fewer entries each year for judging; ask for volunteers in your Post to assemble this important part of your Post's history. Please contact State Headquarters if you have any questions.

When the Community Activity Record Books are submitted for judging they must have the official entry form attached to the inside front cover. The Official Entry Form is in the Commander's Leadership Manual and at the end of these orders and your record book

### **ELECTION AND INSTALLATION OF POST OFFICERS**

Section 217 of the Constitution, By-Laws and Manual of Procedure, states that *prior to* the opening of nominations, the Post shall decide which form of election shall be used, unless the Post By-Laws specify the manner of election.

Any nominee shall have the opportunity to decline nomination for the office to which he has been nominated before nominations are closed. A member making the nomination of an absentee for any office shall have presented to the Adjutant, in writing, the consent of the member being nominated prior to the opening of nominations. Nominations of Post Officers shall open in March and remain open until the Post is ready to vote, provided, however, that when a poll system is used, nominations must be closed at the meeting prior to the election to allow the Adjutant to prepare a printed ballot.

**Post officers shall be elected in April.** Balloting for Post Officers may be conducted by open vote or written secret ballot (handwritten or printed) at a regular Post Meeting, or, if required by Post By-laws or authorized by Post vote prior to the opening of

nominations, by a poll system and preprinted ballot. Absentee ballots and proxy votes are prohibited.

A majority vote of all votes cast, except where otherwise designated, shall be necessary to elect. If there be no election on the first ballot, the name of the comrade receiving the lowest number of votes shall be dropped and so on in successive ballots until an election is made.

If irregularities are claimed with respect to the election to any office, such challenge must be made in a writing containing specific details concerning the irregularities, signed by the challenger, and forwarded to the District Commander, mailed no later than three (3) days after the election.

Complete details regarding the election of Post, District, County Council and Department Officers are available in the 2024 Podium Edition of the National Constitution, By-Laws and Manual of Procedure. Every Post is urged to purchase a copy of the <u>Podium Edition</u> from the <u>VFW Store</u> for a nominal fee.

### NATIONAL BY-LAW CHANGES REGARDING THE ELECTION OF OFFICERS

Officers at all levels should take note of Part 216 and 416 of the National By-Laws regarding the election of officers. Please also take the time to review your Post/District By-Laws.

Section 416 - Elected and Appointed officers; Chairmen and Committees.

(c) The District may elect or the District Commander may appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if required by the District By-Laws.

Section 216 - Elected and Appointed officers; Chairmen and Committees.

(c) The Post may elect or the Post Commander may appoint a Judge Advocate, Surgeon,

Officer of the Day and/or Guard if required by the Post By-Laws.

### **VOTING AT DISTRICT CONVENTIONS**

Each member of a District Convention or District meeting are those persons as defined in Section 404 of the By-Laws, except delegates elected by the Posts, present at a District Convention or meeting shall be entitled to one vote, and an individual possessing more than one qualification for membership in the District Convention or meeting shall have no more than one vote. The delegate or delegates of a Post present at a District Convention or meeting shall be entitled to vote the full delegate strength to which the Post is entitled.

Should there be a division among the delegates representing the Post, each delegate present shall cast his pro rata share of the total voting strength of the Post. For the purpose of this Section (Section 421-Voting), a Post Commander shall be considered a delegate.

A roll call vote may be required and entered upon the record at the call of any three officers or delegates representing three different Posts.

This means that District Elections are determined, not by the number of individuals present and voting, but by the amount of weighted vote that each Post possesses

### 125th VFW NATIONAL CONVENTION

Louisville, KY is the host city for the 125th VFW and 110<sup>th</sup> Auxiliary National Conventions, which will be held **July 27-August 1, 2024.** Convention housing will open March 18, 2024. ### **VFW NATIONAL CONVENTION HOUSING CHANGE**

125th National Convention housing will open, Monday, March 18, 2024. Housing reservation information will be located on the convention website accessed through the main VFW website at vfw.org/convention. The convention website will also have general convention information including the registration form and links to other convention related

information for Louisville, Kentucky – July 27-Aug. 1, 2024, and a tentative agenda.

### **NATIONAL CONVENTION REGISTRATION**

Section 222 of the Manual of Procedure states each Post will pay, in advance, a National Convention Registration Fee of \$25 - which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Please note each additional delegate attending the National Convention will have to pay an additional \$10 delegate fee. Information on delegate registration will be available at a later date.

### Join 2024 VFW Day of Service.

The VFW's third annual VFW Day of Service – a dedicated day of service led by VFW members throughout the country and the world – kicks off the first Saturday on May 4, 2024, and marks the start of veteran-led community service projects to take place throughout the month.

The VFW Day of Service is an outgrowth of the organization's #StillServing campaign launched in 2020 to recognize the ongoing dedication of veterans and service members who continue to serve their communities. Order your poppies now for your Memorial Day distribution or for your Poppy Display. You can order electronically from our webpage - <a href="http://www.vfwil.org">http://www.vfwil.org</a>, or fill out the form and mail or fax or just call us. Please keep in mind:

- You can order in increments of 500. Poppies are priced at \$280.00 per 1,000
   for Traditional poppies or \$140 for Tin tab poppies
- Your poppies should be ordered 6 to 8 weeks in advance of your distribution. State Headquarters does have Poppies in stock. A shipping charge will be added to the invoice for orders that are shipped from this office. Please order early!
- Poppies must be ordered using a name. Your order will be shipped to the *name* of the person who ordered them, but not to "VFW Post \_\_ " or just "Commander" or "Quartermaster".
- <u>Please include a street address</u>. Poppies are shipped via UPS or Fedex and cannot be delivered to a Post Office Box.
- Poppies can be paid for by check or by credit card. <u>Please submit</u>
   <u>payment with your order or pay promptly when invoiced.</u>
- Be sure to put an <u>actual</u> sale date on your order; to avoid paying extra for shipping, **do**<u>not just</u> put RUSH or ASAP. The Cost of shipping for 500 poppies is \$10.05 and for 100 poppies it is \$11.45.
- Poppy cans, caps, table covers, vests, aprons, etc. are ordered directly from the <u>VFW Store</u> at National Headquarters.

Special Note: If you have ordered your poppies from the State
website and didn't pay with a credit/debit card, please do not
send a paper copy of your order form if paying with a check.
This will eliminate the possibility of a duplication of your order.


### RECRUITER CHALLENGE.

### Homeless Veterans

Comrades, winter is back & our Brothers & Sisters living on the street are in desperate need of our help. We all know how cold & windy it gets this time of year. Housing, food & clothing are sorely needed for these Veterans right now. No matter where you live, there is a Veteran in need of some help. A lot of people keep an extra blanket, knit cap, scarf, gloves or maybe some hand warmers in your car for safety reasons in the winter. Now is the time to look in the closet, cedar chest, dresser or wherever you keep your warm clothing & put an extra set in your car for a Veteran in need. How about that flannel shirt, long underwear or sweat shirt that doesn't fit. Now is the time to make good use of it.

Keep some extra candy, granola bars, cheese crackers, slim jims, something of this nature to give out to a needy Veteran. I have a Comrade from the Sandwich post who gives me gift cards from McDonalds, Burger King & Subway to pass out to the Veterans. Something to think about. There is still weeks of winter to go & it can get brutally cold outside. You know what it's like to lose a hat, scarf or pair of gloves when it's cold. Now think of our Veterans living in the elements, no warm clothing, hat, gloves, warm, clean socks. Maybe you are reading this in your kitchen, your office, your living room, nice & warm. Next time you walk out that door into that Bitterly Cold weather, think of our Veterans living out there.

According to the Dept. of Housing & Urban Development, Homelessness among Veterans has decreased from 2020 - 2023. There are a lot of factors that put a Woman Veteran on the street or in the woods. Trauma- experience of trauma before, during or after their time in service that could contribute to housing instability. Military sexual assault, partner violence, poverty, single parenthood. We need to work on these issues .Our programs provide this help.

Besides working this program on the streets, we need to make sure our posts make the monetary donations for the five programs that require a minimum of \$50.00 to department. These five programs all work for the same goal, Veteran Service. Our programs don't run themselves. We need our comrades to work with the directors at the post, district & department levels to get this done.

Remember to report everything that you do for the programs so we can record what you do. Remember, we are a "VETERANS SERVICE ORGANIZATION" That's our mission. Do the work & report the good deeds we do!! Thank you for what you do for our Veterans. Work with your post comrades & the district chairman.
