# **CHANGE OF LOCATION, MEETING PLACE, DAY OR TIME**

Section 205 of the National By-Laws governs the change of Meeting place and/or time for Posts. Posts must follow the outlined procedures if they want to change their meeting time, date or place.

## Sec. 205 - Change of Location, Meeting Place, Day or Time.

A Post may, after at least thirty (30) days written notice to the Department Commander and members of the Post, change its chartered location upon a two-thirds (2/3) vote of the members present and voting at a regular or special meeting. Upon recommendation of the Department Commander, an amended Charter will be issued by the Commander-in-Chief. No change may be effected until an amended Charter is issued.

At such time as the Post changes its location from one community to another, any portion of the Post name that relates to the geographical area or community from which it has relocated shall be deleted from its name.

A Post may, after at least fourteen (14) days written notice to the Department Commander and members of the Post, change its meeting place, appointed day or time upon a majority vote of the members present and voting at a regular or special meeting.

#### **SPAM EMAILS**

If you receive an email from a department officer with a suspicious request, check the sender's actual email address. Remember that a Department Officer will not ask you to send them money or gift cards. Scammers are skilled at making an email appear to come from someone else.

#### **ALL-STATE POST AWARDS**

The 2024-2025 Membership Program is designed to recognize exceptional leadership and teamwork in Membership, overall Post/District development, and VFW Programs. If a Post qualifies to be "All State," all Post members will be recognized for this achievement because they are a team.

#### The 2024-2025 All-State Post Criteria is as follows:

- Membership greater than 101%
- Posts must hold 1 membership drive/event and submit the report to the Program Reporting Dashboard
- Posts must be 100% reported on the Department Programs Reporting Dashboard.
- Posts must have submitted all 4 quarterly Trustees Audits, which must have been approved.
- Posts must be in compliance with all questions on the National and Department Inspection Sheets (for example, a post that is not incorporated shall not be eligible until proof is provided that they are in compliance)
- Posts must order at least 3 poppies per member with a minimum of 1,000.

- Posts must have one nomination for each of the programs of Patriot's Pen, Voice
  of Democracy submitted to the District for judging, or Donations to Voice of
  Democracy and Patriot's Pen will be accepted if a Post does not have a
  nomination. Teacher of the Year or Public Safety, donations to these 2 programs
  do not receive credit towards All-State Awards.
- Posts must have representations at all properly called District Conventions or meetings.
- Posts must have representation at a minimum of one (1) Commanders Calls.
- Posts must make a \$50 donation to the Service Office Support Program (SOS),
   which is separate from the Red, White, and Blue Program donations.
- New Posts need a minimum of 35 members to achieve All-State
- The All-State Program runs through June 15, 2025. The deadline for completing All-State criteria to receive All-State Awards at the State Convention is April 30, 2025. The number of Posts that can achieve All-State status will be unlimited.

All-State Post Commanders will receive an All-State Commander cap and distinguished service lapel pin. All-State Quartermasters may purchase an All-State Post Quartermaster cap and receive a distinguished service lapel pin. All-State Post Members may purchase an All-State Post Member cap.

#### **ALL-STATE DISTRICT CRITERIA**

- Membership greater than 101%
- Districts must have 100% of Posts inspected, and the state inspector must clear the inspections by April 30, 2025.
- Districts must hold a minimum of one School of Instruction and submit a report to State Headquarters.
- The District must hold or participate in one membership drive/event and submit a report to the Programs Reporting Dashboard.
- Districts must submit 1 of each of the following to Department Headquarters for judging:
  - o Patriot's Pen
  - Voice of Democracy
  - Teacher of the Year

- Public Safety of the Year
- Districts must forward a record of the Roll Call of Officers and Posts of each District Meeting to State Headquarters.

## **ALL AMERICAN POST CRITERIA**

- Membership greater than 102%
- Post Election Report must be submitted to National.
- Posts must meet all of the following Program Participation Criteria by January 31, 2025:
- Voice of Democracy- minimum of one entry advanced to District judging.
- Patriots Pen-minimum of one entry advanced to District judging.
- Donate to Veterans and Military Support Program Services. Minimum of \$125
- National Citizenship Education Teachers Award one entry advanced to Department judging.
- A Post must submit a community service report quarterly to their department for submission to the All-American Dashboard. The quarters are July-September, October-December, January-March and April-June. One of these community service activities must be for the VFW Day of Service
- Buddy Poppy minimum 500 poppies

#### **POST MEMBERSHIP AWARD**

- Post membership percentage must be at 98% by December 31<sup>st</sup>, 2024. The Post will receive a special engraved plaque.
- Post reaching 100% by February 28<sup>th</sup>, 2025: The Posts will receive a \$150 Visa
   Gift Card for a post-membership celebration meal recognizing the post efforts.
- Post achieving at least 100% membership by June 30, 2025, will receive a 100% Membership Pennant.

#### **MEMBERSHIP**

Quartermasters are encouraged to go to the Online Membership System (OMS) and click on the reports listing members 30 and 60 days from expiration. All officers are encouraged to make every effort to contact these members and ask them if they are ready to renew their membership or become Life Members before their expiration date. Remember that the Post Relief Fund can help pay the dues of a member who wishes to remain a member but is financially unable to pay his/her dues.

#### **SECTION 219 – RELIEF FUND**

Section 219 of the National by-laws is quoted below:

A relief fund will be established and maintained by the Posts. In this fund shall be credited the net proceeds of the distribution of Buddy Poppies and such other monies as may be solicited or donated for veteran's relief purposes. Expenditures from the relief fund shall be as prescribed in Section 219 of the Manual of Procedure.

Any audit submitted to Department Headquarters that does not indicate the

#### TRUSTEES REPORT OF AUDITS

Per Section 218 of the National Manual of Procedure - Officers and Chairmen, Duties and Obligations, the *Post Commander* must assure that the *Post Trustees* have examined the books and records of the Post and prepared the Post Trustees Quarterly Report of Audit no later than the end of the month following the last day of each quarterly period. Failure on the part of the Commander to strictly enforce Section 218 of the National Manual of Procedure may release the Bonding Company of all liability in case of theft or misuse of funds and subject the Post to suspension. The *duties* of the *Post Quartermaster* include providing the *Post Trustees* with all records, files, and statements required or necessary for the preparation of the Post Trustees Quarterly Report of Audit.

#### **INSPECTION**

Attention is directed to the importance of CONSTANT INSPECTION!! District Commanders will exert every effort to have each Post in their District inspected at least once annually. Post Quartermasters are reminded to be bonded in <u>AN AMOUNT AT LEAST EQUAL TO THEIR LIQUID ASSETS.</u> The District Inspector must contact the Post well before their official inspection, advising the Quartermaster when they will inspect the Post and what items they will need to conduct the Inspection. Each District will be compensated \$10.00 per Post Inspection when the District becomes 100% inspected and approved by the Department Inspector before April 30, 2025.

#### **POST INSURANCE-ADDITIONAL INSUREDS**

According to VFW Bylaws, each Post is required to maintain adequate liability insurance. They also require that National and Department <u>be listed as "additional insureds" on the Post policy.</u> Posts must have their Insurance Agent send a copy of the Insurance Certificate to both National and Department Headquarters. Posts that do not own property do not have to comply with this request.

#### **PROGRAM DONATIONS FOR DASHBOARD CREDIT**

All Posts must donate at least \$50.00 each to VFW State Headquarters for the Military Assistance Program (MAP), Homeless Veterans, Commander's Special Project, Service Office Support, and National Home to receive credit on the State Dashboard. Online donations are encouraged, but <u>don't forget to indicate your Post Number</u>.

#### LOBBY DAY 2025

This year, the IL AMVETS is organizing and hosting the Illinois Veteran's Lobby Day in Springfield, IL, on March 19, 2025. Again, we invite other IL veteran service organizations to join us as we lobby state legislators on various veteran issues. Anyone who wishes to participate should plan on being in Springfield that day. The day will start at 8 am with a meeting of all the participants for coffee and donuts at VFW Post 755. 2211 Old Jacksonville Rd, Springfield, IL 62704. This will be an opportunity for everyone to discuss the planned visits for the day and the talking points to discuss with members of the IL General Assembly. A detailed schedule of the day and the scheduled visits will be handed out at the meeting. At 9:30, we will break up into teams and visit the offices of the State Representatives and the State Senators to talk about the veteran's issues in IL. The day will conclude at approximately 5 pm when we gather at Boone's Saloon, 301 W Edwards St, Springfield, IL (1 block from the State Capitol) for social hour and to discuss the day's results. All the talking points and bill info will be provided, so no lobby experience is necessary. This has been successfully done at the federal level to discuss veterans' issues, and the state lobby day last year was instrumental in helping to get some bills signed into law. Our State Legislators must know what veteran's issues are essential for IL and our members. Please plan to attend and make our IL Veteran's Lobby Day successful.

#### Join VFW Day of Service 2025

The VFW's third annual VFW Day of Service – a dedicated day of service led by VFW members throughout the country and the world – kicks off the first Saturday on May 3, 2025, and marks the start of veteran-led community service projects to take place throughout the month.

The VFW Day of Service is an outgrowth of the organization's #StillServing campaign, launched in 2020, to recognize the dedication of veterans and service members who continue to serve their communities. The VFW Day of Service, led by veterans and in concert with other organizations and civic groups, is open to anyone to participate. We're urging all members and Posts to visit VFWDayofService.org to register their event on the interactive Day of Service map and receive a special participation decal or find a local event to join and see what other veterans around the country are doing to make a difference.

#### **DEPARTMENT BYLAW CHANGES**

Resolutions affecting the Bylaws of the Department must be submitted in <u>proper</u> <u>form</u> and received by State Headquarters by no later than <u>May 15, 2025</u>, so that the resolutions can be circulated to all Posts within the proper time prior to the State Convention. Resolutions concerning the Department By-Laws received after that date cannot be considered at the convention. If you have questions regarding the proper form, please contact State Headquarters.

#### **COMMUNITY ACTIVITIES RECORD BOOK**

Community service, as defined by the National Community Service Trust Act, "encompasses any human act serving the common good in the interest of the community." Community service is "a service that is performed for the benefit of the public or its institutions."

Annually, we ask all VFW Posts to submit record books detailing their Community Service Projects. We encourage Posts to gather pictures, newspaper clippings, letters, receipts, etc., and compile this vital record of their activities in their community. We receive fewer and fewer entries each year for judging; ask for volunteers in your Post to assemble this critical part of your Post's history. Please

get in touch with State Headquarters if you have any questions.

When the Community Activity Record Books are submitted for judging, they must have the official entry form attached to the inside front cover. The Official Entry Form is in the Commander's Leadership Manual, and at the end of these orders, your record book must be at State Headquarters by May 2, 2025, for judging on May 5, 2025

#### **ELECTION AND INSTALLATION OF POST OFFICERS**

Section 217 of the Constitution, By-Laws and Manual of Procedure, states that prior to the opening of nominations, the Post shall decide which form of election shall be used, unless the Post By-Laws specify the manner of election.

Any nominee shall have the opportunity to decline nomination for the office to which they have been nominated before nominations are closed. A member making the nomination of an absentee for any office shall have presented to the Adjutant, in writing, the consent of the member being nominated prior to the opening of nominations. Nominations of Post Officers shall open in March and remain open until the Post is ready to vote, provided, however, that when a poll system is used, nominations must be closed at the meeting prior to the election to allow the Adjutant to prepare a printed ballot.

Post officers shall be elected in April. Balloting for Post Officers may be conducted by open vote or written secret ballot (handwritten or printed) at a regular Post Meeting, or, if required by Post By-laws or authorized by Post vote prior to the opening of nominations, by a poll system and preprinted ballot. Absentee ballots and proxy votes are prohibited.

A majority vote of all votes cast, except where otherwise designated, shall be necessary to elect. If there be no election on the first ballot, the name of the comrade receiving the lowest number of votes shall be dropped and so on in successive ballots until an election is made.

If irregularities are claimed with respect to the election to any office, such challenge must be made in a writing containing specific details concerning the irregularities, signed by the challenger, and forwarded to the District Commander, mailed no later than three (3) days after the election.

Complete details regarding the election of Post, District, County Council and

Department Officers are available in the 2024 Podium Edition of the National Constitution, By-Laws and Manual of Procedure. Every Post is urged to purchase a copy of the <u>Podium Edition</u> from the <u>VFW Store</u> for a nominal fee.

#### **VOTING AT DISTRICT CONVENTIONS**

Each member of a District Convention or District meeting are those persons as defined in Section 404 of the By-Laws, except delegates elected by the Posts, present at a District Convention or meeting shall be entitled to one vote. An individual possessing more than one qualification for membership in the District Convention or meeting shall have no more than one vote. The delegate or delegates of a Post present at a District Convention or meeting shall be entitled to vote the full delegate strength to which the Post is entitled. Should there be a division among the delegates representing the Post, each delegate present shall cast his pro rata share of the total voting strength of the Post. For the purpose of this Section (Section 421-Voting), a Post Commander shall be considered a delegate. A roll call vote may be required and entered upon the record at the call of any three officers or delegates representing three different Posts.

This means that District Elections are determined not by the number of individuals present and voting but by the amount of weighted votes that each Post possesses

# 126<sup>th</sup> VFW NATIONAL CONVENTION

Columbus, OH, is the host city for the 126th VFW and 111th Auxiliary National Conventions, which will be held August 9- 13, 2025. Convention housing will open on March 17, 2025. We will release more information as we receive it.

#### VFW NATIONAL CONVENTION HOUSING

126th National Convention housing will open on Monday, March 17, 2025. Housing reservation information will be located on the convention website accessed through the main VFW website at vfw.org/convention. The convention website will also have general convention information, including the registration form and links to other convention-related information for Columbus, OH – August 9-13, 2025, and a tentative agenda.

#### **NATIONAL CONVENTION REGISTRATION**

Section 222 of the Manual of Procedure states each Post will pay, in advance, a National Convention Registration Fee of \$25 - which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Please note each additional delegate attending the National Convention will have to pay an additional \$10 delegate fee. Information on delegate registration will be available at a later date.

#### **2026 ILLINOIS VFW CALENDAR**

The Council of Administration voted in August to allow the State Headquarters to proceed with a 2026 calendar raffle as part of the Marketing Program. The raffle will begin on Jan. 1, 2026, and run daily through Dec. 31, 2026. The calendars will not be numbered to ensure the prizes are given away rather than to determine if the "winning" calendar has been sold. Each calendar will cost \$20. Only 5,000 calendars will be sold. State Headquarters has created a prize structure and incentive package for Posts selling the calendars. Approximately \$21,500 in prizes will be awarded.

**Incentive Program:** To help State Headquarters sell the calendars, we have developed an incentive program in which each Post selling the calendars would receive \$2 for each calendar sold.

**Sponsorship Programs:** We have several sponsorships for posts, Auxiliary, and members.

**Sponsor a Day**—We have two levels of "Sponsor a Day" sponsorships. For Posts with 100 or fewer members, a day could be sponsored for a donation of \$25. For Posts with 101 or more members, a day could be sponsored for \$50.

In consideration of the sponsorship, the sponsor would be allowed to submit a photo or a tidbit of historical information for that day, which would be included. The photo or information would not have to be about that day. Example: A Post could sponsor their anniversary day, including a photo of their post, the Post's namesake, or information about their post namesake.

**Sponsor a Week** – For \$250, the entire week (Sunday-Saturday) could be sponsored. In consideration of the sponsorship, the sponsor could place three photos and four tidbits of historical information.

**Sponsor a Month** – For \$1,000, the entire month can be sponsored. In consideration of the sponsorship, the sponsor would be allowed to include a display photo (the main photo for that calendar month) as well as additional photos and informational tidbits throughout the month (to be placed on unsponsored days).

Calendars will be printed and available at the Illinois VFW State Convention in June. If your post (or members) is interested in sponsoring a day, week, or month, please let

State Headquarters know. We'll work with the sponsors to ensure their photos and/or information is included on their sponsored area(s).

#### **BUDDY POPPY PROGRAM**

#### Please keep in mind:

- You can order in increments of 500. Traditional poppies are priced at \$280 for 1000 or \$140 for 1000 tin tab poppies.
- Your poppies should be ordered 6 to 8 weeks before your distribution. State Headquarters does have Poppies in stock. A shipping charge will be added to the invoice for orders shipped from this office. **Please order early!**
- Poppies must be ordered using a name. Your order will be shipped to the name of the person who ordered them, but not to "VFW Post \_\_ " or just "Commander" or "Quartermaster".
- <u>Please include a street address</u>. Poppies are shipped via UPS or Fedex and cannot be delivered to a Post Office Box.
- Poppies can be paid for by check or by credit card. <u>Please submit payment</u> with your order or pay promptly when invoiced.
- Be sure to put an <u>actual</u> sale date on your order.
- Poppy cans, caps, table covers, vests, aprons, etc. are ordered directly from the VFW Store at National Headquarters.

Each ticket entitles you to a weekly drawing of \$100 from July 1, 2024 to June 30, 2025. 



#### Prepare for VA's secure sign-in changes

**Note:** We're moving to a simpler and more modern sign-in experience. We'll remove the My HealtheVet option after **January 31, 2025**, and the DS Logon option after **September 30, 2025**.

In 2025, you'll have 2 secure sign-in account options (Login.gov and ID.me) for all VA websites and apps. We'll remove the My HealtheVet option after January 31, 2025, and the DS Logon option after September 30, 2025. You'll still be able to use your My HealtheVet health portal—you'll just need to sign in to it with a Login.gov or ID.me account.

#### Create a Login.gov or ID.me account now

We encourage you to create a Login.gov or ID.me account now. If you already have one of these accounts but haven't yet used it, start now so you have time to get used to it before the change. With Login.gov or ID.me, you'll have access to all the same information and services you use today.

#### My HealtheVet sign-in option Available through January 31, 2025

You'll still be able to use the **My HealtheVet** website after this date. You'll just need to start signing in with a **Login.gov** or **ID.me** account.
