MONTHLY SITREP

District Commanders are reminded to submit a Situational Report (SITREP) to State HQ by the 15th of each month in order to increase the communications to State HQ. The duties and responsibilities of a District Commander includes serving as a liaison between the Post Level leadership and State Level leadership. A monthly report will allow you to review what is happening in your Posts and to communicate any issues to State leaders.

Your SITREP will include information on the following:

What is the current status of audit submissions for each Post? What is your plan to fix any deficiencies?

What is the current status of inspections for each Post? What is your plan to complete inspections at all Posts?

What is the current membership status for each Post? What membership events have they held in last 30 days? What membership events do they have planned for the future?

What Post(s) have you visited in last 30 days?

Does any of your Post(s) need any assistance?

Does any of your Post(s) have any issues that State HQ should be aware of?

Thank you to all who submitted nominations for this month, please continue to do so and for those that did not please look for those comrades from your post who stand apart from the rest by serving the community, Veterans and embodying the purposes of our congressional charter: to preserve and strengthen comradeship among its members; to assist worthy comrades; to perpetuate the memory and history of our dead; and to assist their widows and orphans; to maintain true allegiance to the Government of the United States of America, and fidelity to its Constitution and laws; to foster true patriotism; to maintain and extend the institutions of American freedom, and to preserve and defend the United States from all her enemies.

SECTION 709-CONTROL OF UNITS

POST OFFICERS: Please review Section 709, Control of Units, in the National By-Laws and Manual of Procedure in its entirety. You are not authorized to sell or transfer property, borrow against the assets of the VFW Post without the full knowledge and consent of the Post membership thirty (30) days prior to the sale, purchase, transfer or encumbrance. You must advise all members of the meeting where there will be a discussion of such action. You must notify Department Headquarters of the outcome of this meeting at which time the State Commander will either approve or disapprove the action. Only then

will they authorize the Post to continue with the sale, purchase, transfer or encumbrance. You are reminded that you have a fiduciary responsibility in the position you have been elected to. Any deviations from said By-Laws will nullify the transaction and any officers violating these By-Laws will be subject to removal.

INTERNAL REVENUE SERVICE FORM 990

The deadline for filing the Federal IRS Form 990 is November 15th and the IRS can levy a \$10.00 per day penalty for every day the 990 Form is late. The forms are available on the IRS's website at www.irs.gov. It is the responsibility of the Post Commander and Quartermaster to make sure this form is prepared and submitted on time to the IRS.

AG-990 STATE OF ILLINOIS

Any Post that has applied for a Bingo License, Las Vegas Night License and Gaming License or a Pull Tab License will probably be receiving an AG-990 Form from the State of Illinois Attorney General's office for filing and if you have one of the above licenses, you are required to file this form unless your Post as received an exemption from the Attorney General's Office.

IRS FORM 990-T

VFW Posts that have unrelated business income must file an IRS Form 990-T. The 990-T must be filed by November 15th of each year and this form is available on the IRS's website at www.irs.gov. It is the responsibility of the Post Commander and Quartermaster to make sure this form is prepared and submitted on time to the IRS.

POST RELIEF FUND

Section 704 of the Manual of Procedure outlines the various things for which the Post Relief Fund can be used.

Aid, assistance, relief, and comfort of needy or disabled veterans or members of the Armed Forces and their dependents, and the surviving spouses and orphans of deceased veterans.

Maintenance and expansion of the VFW National Home for Children and other facilities devoted exclusively to the benefit and welfare of the dependents, surviving spouses, and orphans of disabled, needy or deceased veterans or members of the Armed Forces.

Necessary expenses in providing entertainment, care, and assistance to hospitalized veterans or members of the Armed Forces.

Veterans rehabilitation, welfare and service work.

To perpetuate the memory of deceased veterans and members of the Armed Forces, and to comfort their survivors.

To foster true patriotism through historical and educational programs.

Relief funds may be invested in approved securities but shall not be loaned to the Post or other units, or transferred from the relief fund in any manner or under any guise, except that relief funds may be transferred to the general fund for remission of dues of sick, needy or disabled members

The Trustee Report of Audit MUST show a Relief Fund!

FIDUCIARY RESPONSIBILITIES OF THE COMMANDER

Your attention is drawn to Section 218 of the National By-Laws. Among the duties of a Post Commander, the Commander shall:

Assure that the office of the Quartermaster is bonded according to Section 703 of the By-Laws

Assure that all dues and other monies due the National Headquarters and Department are forwarded promptly together with accurate reports and returns pertaining thereto.

Assure that all reports are correctly prepared and promptly forwarded, that all the business of the Post is handled with dispatch and that all necessary licenses and permits are obtained for proper operation. Ensure that a properly completed Report of Election of Officers for the ensuing year is submitted to Department and National Headquarters by June 1.

Assure that the Post Trustees have examined the books and records of the Post and prepared the Post Trustees Quarterly Report of Audit no later than the end of the month following the last day of each quarterly period.

RESPONSIBILITY OF TRUSTEES

Each VFW Post shall have <u>three elected trustees</u> who will, at least monthly, review the Monthly Report of Receipts and Expenditures of the Post Quartermaster. Within thirty (30) days from the end of each quarter, they should properly audit the books and records of the Post Quartermaster and submit a Post Trustee's report of Audit to the Department Quartermaster for referral to the Department Inspector. Please see Sec. 218 of the National By-Laws and Manual of Procedure for complete information on the duties of Post Officers.

PLEASE NOTE:

Before the Department Headquarters accepts an audit, it must be signed by the trustees. You may mail or fax the form to HQ, or you may scan the signed form and email it to HQ, at vfwil@vfwil.org.

COMMUNITY SERVICE GUIDELINES FOR REPORTING

When you are reporting on your activities, please remember - The money that should be reported are the dollars donated or expended in the performance of the community service hours reported, plus \$0.14 per mile for each mile driven by the volunteers. Posts should not report any figure derived from the value of hours worked.

POST COMMANDER & QUARTERMASTER AWARD

Posts recruiting 5% of their prior membership (as recorded on Memstats as new and reinstated members), with a minimum of six members, by January 15, 2023 will receive a special award. The Post Commander and Quartermaster will receive a special embroidered State Commander's jacket. (Note: Partial numbers will be rounded up to the next whole number). Jacket size forms will be sent to qualifying Post Commanders and Quartermasters and these forms must be received at State Headquarters no later than February 15, 2023.

VFW Foundation Grant Opportunities 2022-2023

The VFW Foundation is offering a total of three grants beginning in October 2022. All grants will operate on a reimbursement basis. Applicants will need to do a project and then submit an application with proof of how the funding was spent. Applicants are highly encouraged to contact the VFW Foundation prior to starting a project to ensure it qualifies. Detailed guidelines can be found on the application forms of each grant. 1. #StillServing Grants - Applications Available at www.vfw.org/grants

1. Community Support Grant

This Community Support Grant is offered exclusively to VFW Posts and Auxiliaries to offset expenses incurred while doing a community service project. Districts, Departments, VFW subordinate organizations, etc. may not apply. Both a VFW Post and its Auxiliary can receive funding of up to \$1,500. Applicants are limited to one Community Support Grant award during the October 1, 2022 – June 1, 2023 cycle.

2. District Corporate Partnership Grant

The District Corporate Partnership Grant is offered exclusively to offset expenses related to the community service projects of VFW or VFW Auxiliary Districts that include substantive involvement of a VFW National corporate partner's local affiliate. Posts, Departments, VFW subordinate organizations, etc. may not apply. Applicants are limited to no more than \$1,500 in funding through the VFW District Corporate Partnership Grant award during the October 1, 2022 – June 1, 2023 cycle.

II. Uniting to Combat Hunger Grant - Applications Available at www.vfw.org/utch

1. Uniting to Combat Hunger Grant

The Uniting to Combat Hunger Grant is a matching grant of up to \$1,500 available to VFW Posts and Auxiliaries for monetary and food donations to local food banks and pantries in their communities. The VFW Foundation will provide a \$1 match for every pound of food or dollar donated to these organizations. A Post or its Auxiliary may receive this grant but not both. Applications will be accepted through December 19, 2022. The grant will likely return for a second offering in spring 2023.

Just a reminder of some important dates to put on your calendar and a list of must-have materials to accompany entries that you would advance to the next level of Judging:

V.O.D:

- > October 31, 2022 Local entries must be in hands of Post Chairpersons.
- November 15, 2022 Local winners must be in the hands of the District Chairperson (District Chairperson may designate another timeline with proper notification of posts)
- > December 15, 2022 District judging is to be completed (Sooner, if Possible, Please)
- > December 20, 2022- District winner to Department (Sooner, if Possible, Please)
- February 11, 2023 Department V.O.D. awards banquet Crown Plaza, Springfield

The following is a list of materials that need to accompany all VOD entries into the district judging in order to meet the deadlines for state judging and to keep district winner's identity secret until their respective district award programs:

- Students recorded speech (email or flash drive only no CDs)
- Completed official entry form with all necessary signatures (email preferred)
- A good quality digital, head and shoulders, color photo in the portrait position. (Good quality cell phone pictures are acceptable)
- Student Introductory Questionnaire
- > Typed copy of the essay

VFW-IL 2022 - 2023 STUDENT VETERANS LIAISON

With the ending the fall semester and leading to the spring semester, we are reminded that the VFW-IL can play a critical role in assisting military affiliated students across the state of Illinois. With the re-establishment of school clubs due to more face-to-face classes on campus.

With that said, the **VFW's Student Veteran Support Grant**, administered by the VFW Washington Office, focuses on supporting the overall student veteran population within the community, which consists of many student veterans at campuses across the country that are not affiliated with an SVA chapter. The grants will be disbursed to a VFW Post or Department that has submitted an application, to support the student veterans at the university or college. Grants may be awarded up to \$500 to support each event, and grants can be awarded to a VFW entity twice each fiscal year, totaling up to \$1,000. Here is the link to apply:

Sport Clips Haircut's Record-Breaking \$1.55M Donation Makes Education Goals a Reality for Hundreds of Veterans

In January, the VFW and Sport Clips were pleased to announce 146 student veterans will receive scholarships for the Spring 2022 semester, totaling nearly \$650,000. This brings the number of scholarship recipients to 2,200 and makes the program one of the largest veteran support programs of its kind.

VFW Auxiliary Continuing Education Scholarship

The scholarship assists members and their immediate family members who wish to further their education by pursing a college degree or career direction at a vocational/technical school. Four \$1,000 scholarships will be awarded each year, one in each of the four VFW Auxiliary Conferences.

The following are VFW National's 2022 Priority Goals pertaining to education:

- Improve education benefits through increased online student housing allowances, childcare stipends, parity for Guard and Reserve members, and elimination of delimiting dates.
- Enhance outreach and counseling for Veteran Readiness and Employment eligible veterans.
- Fund and track outcomes for career-focused training programs.

Pending legislations (U.S. Senate & House of Representatives):

S. 3606, A bill to amend title 38, United States Code, to eliminate the requirement to specify an effective period of transfer of Post-9/11 educational assistance to a dependent, and for other purposes.

The VFW supports this bill, which would eliminate the requirement to specify an effective period of a transfer of Post-9/11 educational assistance to a dependent. In cases where a service member

dies before the educational assistance is used, unnecessary red tape is a hurtful barrier if the surviving family is unavailable to clarify clerical errors. The process of transferring education benefits to a dependent should be as transparent and seamless as possible, and this bill would help eliminate a field which serves no real utility. This legislation would make it easier for all veteran and military families using VA education benefits and would be of significant importance to Gold Star Families.

(Passed the Senate Aug 04, 2022)

S. 4319, Informing VETS Act of 2022

The VFW supports this proposal to better inform veterans about the opportunities offered through the Veteran Readiness and Employment (VR&E) program. Currently, according to data released by the Bureau of Labor Statistics, the unemployment rate for all veterans in America in June of this year was 2.7 percent. While this is good news regarding veteran employment, the VFW understands this situation can be cyclical. If we do not put proper tools in place, we could see these numbers rise again during this country's next period of financial instability. VR&E offers a proven system that enables veterans to retrain for their next career, allowing them to continue participating in the American dream of prosperity.

(Read twice and referred to the Committee on Veterans' Affairs: May 26, 2022)

S. 4458, Ensuring the Best Schools for Veterans Act of 2022

The VFW supports this bill to improve the process by which the Secretary of Veterans Affairs determines whether an educational institution meets certain requirements for enrollment. VA's 85-15 rule is not meant to prohibit veterans from utilizing their earned education benefits. However, due to recent changes that had unintended consequences, certain schools were unsure if they could enroll veterans in courses. This proposal takes input from schools and veteran advocates to make sure veterans are able to use the benefits they have earned while schools still maintain quality standards.

(Passed both the House and Senate; Presented to President: Aug 23, 2022)

H.R. 1836: Guard and Reserve GI Bill Parity Act of 2021

This bill expands eligibility for Post-9/11 GI Bill educational assistance and addresses other Department of Veterans Affairs (VA) programs and benefits. Specifically, the bill expands the type of duty that is eligible for such educational assistance. (Passed the House Jan. 11, 2022)

Illinois Legislation

A lot is going on in Illinois at the County and State level. first, the veto session, 2d week of November and this will include our lame duck legislators. Two things to watch for. Attempt to change the funding in the Military Veterans Assistance Act. Illinois State County Officials Association has publicly opposed the .02 mil rate in the act.

Second, a possible addition in the definition of Veteran Service Organization. I personally would urge that the definition used in the Illinois Joining Forces Act be adopted. The Attorney Generals Office has offered a definition and additional over sight by the AG. If we the VFW at the post level do our due diligence the additional over sight is not necessary. It is up to us.

On October 31, the Lake County Forest Preserve District legislative committee meeting. I am confident that they will move to have the state general assembly approve the transfer of 4.7 acres to the Fort Sheridan National Cemetery. The initial agreement had the army transfer 290 acres from Fort Sheridan to the Forest Preserve. The District was to maintain the cemetery and golf course. The cemetery was later transfered from the Army to the VA. As a VA cemetery it quickly filled up and the additional acres per the VA will extend its life for 50 years. Who would have thought that we would have to argue with our county officials to expand a VA cemetery. I am also confident that we will have approval from the state. However, I need every post to get a committment from their State Senator and Representative to support the transfer. The Forest Preserve is not a home rule district and the transfer requires state approval.

Congratulations to the Sangamon County VAC on their resolution to create a super CBOC in Springfield similar to Peoria. The resolution has been sent to Senator Duckworth as a member of the Senate Veterans Affiars committee to create a bill and approval by the committee. Again, every post should urge their legislators to support the CBOC for Springfield. Will adivse when we get a Bill number.

The Illinois. Veterans Advisory Council meets December 14th. A new Chair and Vice Chair will be elected. Its been my honor to Chair the committee the past two years. Its been difficult, one in person meeting. Covid outbreak at LaSalle, new Director and he is a good one, a good working relationship with Senate and House Veterans Affairs Committee members and then passage of our amendment for surviving spouses at 3AM in the morning.

We did good, we passed 10 out of our 13 priority bills. The remaining 3 are in rules committeee.

At the National Convention, we passed our resolutions. I am very proud of our resolution to give veteran status to Guard and Reserve retirees. These are good patriots who served 20 years but were never mobilized and thus no DD 214. My concern is getting them admitted to a State Veterans Home, but without DD214 showing active duty the VA will not pay the state the per diem. Just last year, we created the DD Form 214-1 to show all service but this does not change their status. We also passed legislation to cover state active duty that exceeds 14 days by USERRA.

If you have concerns about legislation, please talk to your legislators. As veterans you are their subject matter expert, very few legislators and staff members have military service. I thank you for allowing me to serve.

NEW INFORMATION

People who spent time in the United Kingdom, Ireland and France between 1980 and 2001 have been ineligible to give blood over concerns of a variant related to "mad cow" disease. That donor restriction is now lifted.

Mad cow disease may be a fleeting memory for some, but concerns over Creutzfeldt-Jakob Disease (vCJD) kept tens of thousands of people, often members of the military and their families, from giving blood.

Recently, the U.S. Food and Drug Administration updated its blood donor eligibility guidance on CJD. Dawn Johnson is with the Red Cross Cascades Region and said anyone who hasn't tried because of the prior donation criteria should know they are now welcome to give.

We always need blood donations," she said. "The need is continuous and so being able to have more people donate is definitely a positive."

Johnson said American Red Cross Cascades Region has so far sent 300 units of blood to Florida to aid in the disaster relief following Hurricane Ian.
