STATE HEADQUARTERS CLOSURES

The State Headquarters will be closed on October 14th for Columbus Day.

SPAM EMAILS

If you receive an email from a Department Officer with a suspicious request, check the actual email address of the sender. Keep in mind that a Department Officer will not ask you send them money or gift cards. Scammers are very skilled at making an email appear that it came from someone else.

NATIONAL BY-LAWS: POLITICS SEC. 702- POLITICS.

No officer or member of the Veterans of Foreign Wars of the United States shall in any manner use the Veterans of Foreign Wars for partisan politics and no discussion of partisan questions shall be permitted at any meetings nor shall any nominations, recommendations or endorsements for political office be made, provided this shall not apply to discussion of policies of any organization that seeks to alter our present form of government by force, violence or other unlawful means.

Participation in activities supporting or opposing legislation or administration of laws for veteran's welfare or relating to other matters pertaining to the purposes of the organization shall be permitted. Such participation shall be consistent with the legislative and welfare programs and policies approved by the National Convention.

No Post, County Council, District or Department shall participate in a labor dispute, either on behalf of labor or management. No member of the Veterans of Foreign Wars of the United States shall wear the VFW uniform or VFW cap in any plant or picket line or meeting of employees where a labor dispute arises.

ALCOHOLIC BEVERAGES, SMOKING, AND VAPING DURING POST MEETINGS

Below is an extract from the National VFW General Orders for October 2023 regarding Alcoholic Beverages, Smoking, and Vaping during Post Meetings.

Attention of Post Commanders is directed to the Commander-in-Chief's decision in response to questions raised concerning alcoholic beverages and smoking/vaping in the Post meeting room during the Post meeting as set forth below:

It is held to be objectionable and contrary to accepted rules of order and proper decorum implicit in the ritual of the Veterans of Foreign Wars to permit alcoholic beverages or the use of smoking/vaping products in the Post meeting room during the Post meeting. Accordingly, the presence, dispensation, and/or consumption of alcoholic beverages or the use of smoking/vaping products in VFW meeting rooms during VFW meetings are unacceptable and are prohibited.

It is the intent of the Commander-in-Chief's decision, regarding this response, to include Post, County Council, District and Department meetings, whereas it is held to be objectionable. Please refer to section 1001 (25) of the National Manual of Procedure.

Section 1001-25 is quoted for your information and necessary action. "25. The dispensation and/or consumption of alcoholic beverages or use of smoking/vaping products in VFW meeting rooms during VFW meetings are prohibited."

ATTN: DISTRICT OFFICERS

District Meetings are meant to be a school of instruction. District Commanders must make sure instruction is taking place at their meetings. Training is very important to the success of our organization; without it we lose members and Posts. The national web site, www.vfw.org, contains a great wealth of information that can be used in schools of instruction. Use these materials and more to cause your attendees at District Meetings to leave the meeting knowing more than they did when they arrived. Department representatives are available, from time to time, to provide training at District Meetings or at Schools of Instruction called outside of the normal District Meeting Schedule. Should more than one District decide to join together for a school of instruction a Department Representative is almost sure to attend if invited.

RED, WHITE AND BLUE VETERANS SERVICE SUPPORTER PROGRAM

Districts, Posts and Individuals can once again show their support for our Veterans Service programs through our Red, White and Blue Supporter Program. We have established three levels of Sponsorships - Red for those making donations of at least \$1,000; White for those making \$500 donations; and Blue for those making donations of \$250. Individuals, Posts, Districts and Auxiliaries making donations in the above Supporter Levels will receive a beautiful plaque noting their level of support and signs noting donations will be displayed at the Mid-Winter Conference in February and our 106th annual State Convention in June, 2025.

TEACHER OF THE YEAR AND PUBLIC SAFETY AWARDS

The Commander's Leadership Manual for 24-25 has the requirements for Teacher of the Year and the Public Safety Awards. The Public Safety Awards only include these 5 awards: Law Enforcement, Firefighter, EMT/Paramedic, Emergency Dispatcher, and Explosive Ordnance Disposal (EOD) Technician.

Attached to the General Orders is an extract from the Commander's Leadership Manual on Teacher of the Year and Public Safety Awards

For a Post to achieve All State Honors they must submit a Teacher of the Year nomination OR they must submit a Public Safety Award nomination.

For a District to achieve All State Honors they must submit a Teacher of the Year nomination AND they must submit a Public Safety Award nomination.

BONDING OF ACCOUNTABLE OFFICERS

ATTENTION QUARTERMASTERS: Sec. 703 of the Veterans of Foreign Wars of the United States By-Laws requires each accountable officer to be bonded with an indemnity company in a sum at least equal to the amount of liquid assets for which they may be accountable. Posts that are not properly bonded are subject to disciplinary actions.

If you have yet to submit your bond application, one is available on our State of Illinois Website by going to www.vfwil.org. Go to "Resources" and click on "Reports & Forms" on the drop down menu. You will find a blank Bond Application on that screen. Complete the application and mail it, along with the payment to Department. *All bonds not renewed expired on August 31, 2024.*

QUARTERLY REPORT OF AUDIT

Sec. 218 (I 1) b. of the Veterans of Foreign Wars of the United States Manual of Procedure Within thirty (30) days from the end of each quarter, properly audit the books and records of the

Post Quartermaster, Post Adjutant, and any activity, club room, holding company or unit sponsored, conducted or operated by, for or on behalf of the Post and submit a Post Trustee's Report of Audit to the Department Quartermaster for referral to the Department Inspector.

These are the Quarters for the audits, March, June, September and December.

Audits are due 30 days after the Quarter to State Headquarters. Every report must be in accordance with and upon such form as may be prescribed by the Adjutant General. Post Leadership; remember that the audit is the tool used to inform the Post Membership of the financial status of the Post. We owe our members an accurate and timely reporting. A thorough, complete audit can prevent financial problems down the road.

Those Posts that are delinquent in submitting a Trustee's Report of Audit are subject to being suspended by the State Commander.

PROGRAM REPORT SCOUT OF THE YEAR OCTOBER 2024

Purpose: Annually the VFW honors Scouts who have been the recipient of one of the following awards, Eagle Award, Venture Summit Award, Sea Scout Quartermaster Award and for Girl Scouts Gold Award.

Guidelines: The VFW State will recognize the Scouting America first place winner and the Girl Scout first place winner and received an invitation to the State Convention. Each will receive a \$300.00 cash award. Only the top winner will be forwarded to National.

The Posts should appoint a scouting liaison to maintain contact with the local scouting units and if the opportunity presents itself become a Chartering Organization for a scouting unit.

Procedures:

- A post may only sponsor one Scout of the Year applicant. If more applications are
 received the post may refer the applicant to other VFW Posts. The post should review
 the applicant's package, to ensure the applicant has followed the guidelines on the
 application. The following deadlines must be followed:
 - Student Entry to Post 1 March
 - Post/District Entry to State Headquarters 1 April
 - State Winner to National 1 May
 - District entrants should be submitted to the district Scouting Chair between 1 March and 31 March for judging.

(Please note Deadlines)

This Program recognizes teachers who care about America. VFW annually recognizes the Nation's top classroom Elementary, Junior High (Middle Schools) and High School teachers who teach Citizenship Education topics regularly and who promote American History, traditions and institutions. Nominations are submitted by fellow teachers, supervisors and other interested individuals (not relatives). Self-nominees are not eligible.

National Headquarters mails these brochures out directly to the Schools but....Posts still need to contact the schools regarding this Program.

Posts will need to follow up as deadlines are as follows:

- Teacher Nominations to Post October 31, 2024
- Completion of Post Judging November 15, 2024
- Completion of District Judging December 15, 2024
- District winners due to State HQ December 22, 2024
- District Participation Report due to State HQ December 29, 2024
- Completion of Department Judging January 10, 2025
- Department winners to National January 15, 2025
- Department Reports to National January 31, 2025

District Chairmen must send the following to Department Headquarters for Judging:

- Winner's original entry form and essay of 350 words or less
- · Winner's official Post Teacher Entry form with signatures at Post & District Level.
- One page resume (no more than two sides)
- Up to 5 (five) pages (both sides) of additional documentation (i.e. news articles, supervisor's recommendations.)
- Good quality head and shoulders photograph (color copies or low grade computer printouts will not be accepted)

(Note: No entries will be considered for Department Judging if all of the above criteria is not included with the nomination)

State Awards

The first place winner in each of the three categories will receive \$100.00 Cash and a special engraved plaque. A special engraved plaque will also be presented to the winning Teacher's School.

The Categories are:

- · Kindergarten through 5th Grade,
- · 6th through 8th Grade, and
- 9th through 12th Grade.

What is the Teacher Award Program?

Founded in 1899, the VFW highly supports the education of America's youth. VFW and its Auxiliary have developed a slate of programs dedicated to helping America's educators. VFW Citizenship Education programs stimulate interest in America's history, traditions, Americanism, civic responsibility, flag etiquette and patriotism.

Teachers care deeply about America and its children. They're concerned about the perpetuation of America's noblest traditions and highest ideals. Wouldn't you like to see them get the honor they deserve? Now you can.

Why Should I Enter?

VFW wants to identify and recognize America's best educators who instill a sense of national pride in students. The national awards include \$1,000 Smart/Maher award for each of the top K-5, 6-8, and 9-12 teachers for professional development expenses, \$1,000 award for each winning teacher's school, commemorative plaques and all-expense-paid trip to the VFW National Convention.

Who is Eligible?

All current certified/licensed teachers in grades K-12 are eligible. Previous national VFW winners are ineligible. Nominations can be submitted by themselves, fellow teachers, supervisors, family members or other interested individuals.

How are teachers nominated?

Fill out the official entry form contained on the next page, and provide a one-page resume as a minimum or up to five pages, including the resume, as a maximum of documentation of their teaching experience (for example: resume, references, news articles, etc.) and a head-and-shoulder photo if available.

Please submit your completed entry form signed, along with the required documentation to your local VFW Post. Visit vfw.org/FindaPost for Post locations or call VFW Programs Department at 816.756.3390 ext. 6287 to find the Post nearest you.

What Is the Deadline for My Entry?

All entries competing at the Post level must be in the hands of that VFW Post by midnight, Oct. 31, 2024. It is the responsibility of the nominator to meet this deadline by submitting their entry to the proper location by ensuring it is a participating Post.

What Are the Judging Criteria?

Citizenship (1-25 points): On a scale of 1-25, to what extent does the teacher encourage and/or model good citizenship and community involvement?

Innovation (1-25 points): On a scale of 1-25, how much innovation (new ideas, new tools, new resources, and new approaches) does this teacher utilize in the classroom? Does this teacher's effort reflect an ongoing desire to stimulate the students with new things?

Resources (1-25 points): On a scale of 1-25, to what degree has this teacher demonstrated an ability to identify and utilize new and exceptional resources to fund, facilitate and provide materials for his or her classroom? Does this teacher tap into outside agencies, organizations and individuals to acquire materials and expertise in the classroom? As an example – bringing speakers, finding in-kind and monetary donations, or utilizing local opportunities like museums, field trips and local events.

Passion (1-25 points): On a scale of 1-25, to what degree does this teacher appear to be passionate about the profession of teaching? Are they regularly seeking to upgrade their skills? Do they try and find ways to encourage their students? Do they take a personal interest in their student's individual success?

SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD CITATIONS FOR ELEMENTARY, MIDDLE AND HIGH SCHOOL TEACHERS AND THEIR SCHOOLS

Each year, the Veterans of Foreign Wars selects elementary, middle and high school teachers to participate in the Smart/Maher VFW National Citizenship Education Teacher program. Effective this year, VFW Post Teacher Award Chairman may submit one candidate to their **Department Headquarters by January 1, unless your state does district judging.** The Department will select a single candidate and submit them to **VFW National Headquarters by February 1 for national judging.** VFW's Department Teacher winners that are received at National Headquarters will receive a VFW National citation for both the winning teacher and their school.

NOTE: The only item the National VFW Programs Department requires is the completed "VFW Department Teacher Award Citation Request Form" which is now available on the VFW website. Simply visit wfw.org/#login, log in to My VFW, then look under Member Resources, click on VFW Training & Support, then click on Community Service & Youth Programs, then look under Additional Resources. The Teacher Entry form, Instruction sheet, Citation request form and Chairman's Manual will be up on the VFW website in the near future.

Who Is Eligible?

- 1. Teachers who promote civic responsibility, flag etiquette and patriotism are prime candidates for this award. For example, do you know a teacher who plans field trips to city hall or organizes community volunteer projects? Maybe you know an instructor who invites veterans into the classroom to discuss their military experiences. Perhaps you are familiar with a teacher who fosters the development of democratic values and beliefs through special projects. If you know of such a teacher, honor him or her today.
- 2. All current certified/licensed teachers in grades K-12 are eligible. Previous national winners are ineligible. Nominations can be submitted by themselves, fellow teachers, supervisors, family members or other interested individuals.

Documentation Required for all Candidates:

All Post-level nominees should provide a one-page resume as a minimum or up to five
pages as a maximum of documentation of their teaching experience (for example:
references, news articles, etc.) and a head-and-shoulder photo of themselves, if available.
These items will be forwarded on to the Department with the winning teacher entry form.

PUBLIC SERVANT RECOGNITION (National)

PUBLIC SERVANT AWARD CITATIONS FOR EMERGENCY MEDICAL TECHNICIANS, LAW ENFORCEMENT PERSONNEL, EOD TECHNICIANS, EMERGENCY MEDICAL DISPATCHERS, AND FIREFIGHTERS

Each year, the Veterans of Foreign Wars selects emergency medical technicians, law enforcement, 911 dispatchers and firefighter personnel to receive VFW Public Servant Awards. Post Safety Chairmen are encouraged to submit a candidate for these awards to their Department Headquarters by Jan. 1. The Department must select a single candidate for each of the four awards and submit those to VFW National Headquarters by Feb. 1.

NOTE: The only item the National VFW Programs Department requires is the "VFW Department Public Servant Award Citation Request Form" which is now available on the VFW website. You can locate this form by logging in to vfw.org and searching under "My VFW" in the Training & Support section.

VFW National Emergency Medical Technician Public Servant Citation:

Any individual, who actively gives emergency medical treatment, provides rescue service or civil disaster assistance as a member of any public or volunteer company organized to give emergency medical care, provide rescue and civil disaster assistance to our nation's citizens.

VFW National Law Enforcement Public Servant Citation:

Any individual who serves in a municipal, county, state or federal unit tasked with enforcement of the laws pertaining to their area of responsibility. This award does not apply to individual employed by private companies or security services.

VFW National Emergency Medical Dispatcher Citation Any individual who is employed by a 911 Dispatch Center

VFW National Firefighters Public Servant Citation: Any individual who actively fights fires as a member of any public or volunteer company organized to fight fires and give assistance to our nation's citizens.

EOD Technician

Criteria for these awards - Candidates must have demonstrated:

- 1) Recognition by their colleagues or those they serve.
- 2) Consistent excellence in the performance of their duties.
- 3) Consistent dedication to their official responsibilities over a period of years and continuous growth in responsibilities and skills within their profession.

Documentation required for all Candidates:

- 1) Nomination letter containing the candidate's name, title, address, telephone and identifying the award for which the individual should be considered.
 - a. Include justification outlining background in field, accomplishments and awards.

Project Based Voucher Waitlist Opening

Otto Square Veteran's Housing

The Housing Authority of Cook County (HACC) will be re-opening its site-based wait lists to **veterans only** for one- and two-bedroom project-based voucher (PBV) units for Otto Square Veteran's Housing located at 1440 Otto Blvd. in Chicago Heights IL 60411. Otto Square is an 82 unit new construction community designed with the purpose of providing quality, affordable housing for our country's veterans.

The PBV Program is a rental assistance program where the resident pays 30% of his/her income towards the rent. To be eligible for the PBV units, the applicant's household income may not exceed the very low income limit (50% AMI), which is as follows:

\$39,250 for a 1 person household

\$44,850 for a 2 person household

\$50,450 for a 3 person household

\$56,050 for a 4 person household

The maximum occupancy standard is 2 people per bedroom. Families are assigned a unit size based on the HACC's subsidy standards. Families with more than 4 people will not qualify.

Applications will be available beginning on Monday, October 7, 2024 at 10:00 a.m. To apply, applicants need to log onto the HACC's website at www.thehacc.org. Scroll down and click "Open Wait List" on the HACC's home page. Select the desired property and then click "Apply to Wait List." The wait list will close at 4:00 p.m. on Friday, October 18, 2024.

Applications must be submitted electronically through the website. At this time, **only applications submitted by veterans will be added to the wait list**; the order of placement on the wait list will be based on a randomized computer-generated lottery system. Applications from non-veterans will not be added to the wait list.

To identify as a veteran. make sure to check the "US Military Veteran" box on the "Waiting List Preferences" page of the application. For verification of veteran status, veteran applicants MUST submit a copy of their DD214 at the time of application. It must be submitted to pbvwaitlist@thehacc.org with "Otto Veteran Verification" in the subject line. Applications submitted without the DD214 will not be added to the wait list. Veteran applicants who are currently on the HACC's Housing Choice Voucher (HCV) Program wait list will receive a preference.
