STATE CONVENTION REGISTRATION

Included in these General Orders is the Advance Registration Form for the State Convention. Delegates can also be registered online by going to www.vfwil.org. The registration fee is \$20.00 until May 31, 2025, and is \$22.00 after May 31, 2025.

Letters of registration confirmation will be mailed to registrants after the proper registration fee has been paid. Registrants will be required to present this confirmation when they check in at the convention registration desk at the BOS Convention Center.

REMINDER: Delegates <u>will not</u> be allowed to vote until such issues have been resolved if the Post is in arrears for supplies, poppies or any sort of financial obligation to the Department. The Post must be bonded, inspected, have an election report on file with Department and National Headquarters for the ensuing year, and all audits **including the March 31, 2025 audit** must be submitted and approved.

Delegate strength to the convention is based on one delegate and one alternate delegate per thirty members or fraction thereof.

SOLICITATION OF FUNDS

Pursuant to Section 214 - "Solicitation of Funds" found in the National By-Laws and Manual of Procedure, fundraising may only be held for sanctioned purposes. This means no member shall use his/her title, position or office in connection with solicitation of funds for any non-VFW related purpose. Violation of this provision may lead to penalties which may include removal from office.

MARCH 25TH ... "MEDAL OF HONOR DAY"

A Resolution was passed by the U.S. Senate which designates March 25th as "National Medal of Honor Day". The day is set aside to acknowledge the more than 3,400 individuals who have received the nation's highest honor. The date of March 25th was chosen to highlight this special day because it was on March 25, 1863, that the first Medals of Honor were presented to six members of Andrews' Raiders. According to the Medal of Honor Society, there are only 83 living individuals who have received the 'Medal of Honor" and the Department of Illinois is proud to be "home" to three of them. 4308-5 and Sammy Davis, Post 4549-17. Let's all join in recognizing their dedication and service to our country.

LOBBY DAY 2025

This year, the IL AMVETS is organizing and hosting the Illinois Veteran's Lobby Day in Springfield, IL, on March 19, 2025. Again, we invite other IL veteran service organizations to join us as we lobby state legislators on various veteran issues. Anyone who wishes to participate should plan on being in Springfield that day. The day will start at 8 am with a meeting of all the participants for coffee and donuts at VFW Post 755.

2211 Old Jacksonville Rd, Springfield, IL 62704. This will be an opportunity for everyone to discuss the planned visits for the day and the talking points to discuss with members of the IL General Assembly. A detailed schedule of the day and the scheduled visits will be handed out at the meeting. At 9:30, we will break up into teams and visit the offices of the State Representatives and the State Senators to talk about the veteran's issues in IL. The day will conclude at approximately 5 pm when we gather at Boone's Saloon, 301 W Edwards St, Springfield, IL (1 block from the State Capitol) for social hour and to discuss the day's results. All the talking points and bill info will be provided, so no lobby experience is necessary. This has been successfully done at the federal level to discuss veterans' issues, and the state lobby day last year was instrumental in helping to get some bills signed into law. Our State Legislators must know what veteran's issues are essential for IL and our members. Please plan to attend and make our IL Veteran's Lobby Day successful.

Join VFW Day of Service 2025

The VFW's fifth annual VFW Day of Service – a dedicated day of service led by VFW members throughout the country and the world – kicks off the first Saturday on May 3, 2025, and marks the start of veteran-led community service projects to take place throughout the month.

The VFW Day of Service is an outgrowth of the organization's #StillServing campaign, launched in 2020, to recognize the dedication of veterans and service members who continue to serve their communities. The VFW Day of Service, led by veterans and in concert with other organizations and civic groups, is open to anyone to participate.

DEPARTMENT BYLAW CHANGES

Resolutions affecting the Bylaws of the Department must be submitted in <u>proper</u> <u>form</u> and received by State Headquarters by no later than <u>May 15, 2025</u>, so that the resolutions can be circulated to all Posts within the proper time prior to the State Convention. Resolutions concerning the Department By-Laws received after that date cannot be considered at the convention. If you have questions regarding the proper form, please contact State Headquarters.

COMMUNITY ACTIVITIES RECORD BOOK

Community service, as defined by the National Community Service Trust Act, "encompasses any human act serving the common good in the interest of the community." Community service is "a service that is performed for the benefit of the public or its institutions."

Annually, we ask all VFW Posts to submit record books detailing their Community Service Projects. We encourage Posts to gather pictures, newspaper clippings, letters, receipts, etc., and compile this vital record of their activities in their community. We receive fewer and fewer entries each year for judging; ask for volunteers in your Post to assemble this critical part of your Post's history. Please get in touch with State Headquarters if you have any questions.

When the Community Activity Record Books are submitted for judging, they must have the official entry form attached to the inside front cover. The Official Entry Form is in the Commander's Leadership Manual, and at the end of these orders, your record book must be at State Headquarters by May 2, 2025, for judging on May 5, 2025

CONVENTION AWARDS AND CITATIONS COMMITTEE:

We are accepting nominees to be considered by our Convention Awards & Citations Committee for our State Convention. Categories for these awards are Outstanding Legislator, Education, Outstanding in Industrial Field, Legal Profession, Athletic Field, Governmental Service, Clergy, News Media, and Outstanding Citizen

or Community.

NOMINATION, ELECTION AND INSTALLATION OF OFFICERS

Section 216 of the National By-Laws is quoted below for your information and necessary action. Please note paragraph c.

Sec. 216 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The Post shall elect the Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain and three Trustees.
- (b) The Commander shall appoint an Adjutant and Service Officer.
- (c) The Post may elect or the Post Commander may appoint a Judge Advocate, Surgeon, Officer of the Day and/or Guard if required by Post By-Laws.
- (d) The Post Commander may appoint such other chairmen and committees as deemed necessary to conduct the affairs of the Post or as may be required by Post By-Laws.

A number of posts have by-laws that state that Post Officers will be elected in accordance with the National By-Laws or are silent on the election of officers as the National By-Law has precedence. With the change to 216c should review their by-laws and decide if they wish the positions in 216c to be elected or appointed.

Section 416 of the National By-Laws is quoted below for your information and necessary action. Please note paragraph c.

Sec. 416 - Elected and Appointed Officers; Chairmen and Committees.

- (a) The elected officers of each District shall consist of a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain, and three (3) Trustees.
- (b) The Commander shall appoint an Adjutant, Service Officer and Inspector.
- (c) The District may elect or the District Commander may appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if required by the

District By-Laws.

(d) The District Commander may appoint such other chairmen and committees as deemed necessary to conduct the affairs of the District or as may be required by District Bylaws.

Paragraph c allows Districts to choose between election or appointment of the listed officers. Should the District wish to appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day they need to have this reflected in their by-laws.

Section 417 of the Manual of Procedure

Sec. 417 - Nomination, Election, Installation and Term of Office. Order of nominations and elections.

The order of nominations and elections shall be Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain, Judge Advocate, Surgeon and Trustee(s).

Nomination. A member may be nominated and elected although not present at the meeting. A member making a nomination of an absentee for any office shall have presented to the Adjutant, in writing, the consent of the member being nominated prior to the closing of nominations. Any nominee shall have the opportunity to decline nomination for the office to which they have been nominated before nominations are closed. Nominations shall remain open until the District Convention is ready to vote.

Election. In balloting for District officers, a majority of all the votes cast shall be necessary for election. If there is no election on the first ballot, the name of the comrade receiving the lowest number of votes shall be dropped and so on in successive ballots until an election is made.

Challenging Election Results: If irregularities are claimed with respect to the election to any office, such challenge must be made in a writing containing specific details concerning the irregularities, signed by the challenger, and forwarded to the Department Commander, mailed no later than three (3) days after the election.

Installation. District officers shall be installed before the adjournment of the meeting at which elected. The installation shall be conducted by a member in good standing who holds or has held an office equal to or higher than District Commander. The District Commander-elect shall select the installing officer. An officer who may be absent for good and sufficient reason or cause shall be installed at any succeeding regular or special meeting of a unit of the organization, within sixty (60) days of the date of installation. If not then installed, the office will automatically become vacant.

Term of Office. Officers shall be elected for a term of one (1) year except that three trustees shall initially be elected for terms of one (1), two (2) and three (3) years and thereafter one (1) trustee shall be elected each year for a term of three (3) years. District officers shall take office upon the confirmation of election and installation of the Department Commander by the Department Convention.

INSTALLING OFFICERS

Installing officers will see that the provisions of Section 216 of the National Bylaws and the Manual of Procedure are properly carried out and that all officers are members in good standing and qualified to hold office prior to installing Post officers for the current year. Post officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed.

Post Election Reports must be submitted following Post election of officers in April and no later than June 1 to the National Headquarters. We highly encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to the Department Headquarters.

SPECIAL NOTICE REGARDING DISTRICT CONVENTIONS

The District Convention is held for the purpose of electing vour officers for the upcoming administrative year. Any member, not a member of the District Convention, (Refer to Section 404 of the National By-Laws) may attend the Convention, however, they shall have no voice in business discussions unless requested by the Commander, and shall have no voting privileges. Those on official business shall be recognized by the Commander for the conduct of business. (Article IV, Sec. 403 - Regular, Special and Committee Meetings; Convention; Quorum; Authorized Attendees.)

PROOF OF ELIGIBILTY REQUIRED FOR ALL ELECTED AND APPOINTED OFFICERS

Officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Proof of eligibility shall be open to and reviewed by the District Commander, Adjutant and Quartermaster prior to installation to office.

Per Section 416: District Officers, elected and appointed, shall submit proof of eligibility to District Adjutant. Additionally District Commander, District SR. Vice, and the District JR. Vice shall submit proof of eligibility to the Department Adjutant.

In the event an elected or appointed officer fails to submit proof of eligibility within thirty (30) days of election or appointment, any right of the officer to hold the office shall be forfeited, the office declared vacant and the eligibility qualifications of such officer shall be questioned in accordance with the provisions of Section 108 of the National By-Laws.

COMMANDERS-ELECT AT ALL LEVELS

Your attention is directed to the fact that the State Commander does NOT ASSIGN a Past Post, District, County Council Commander or a State Officer to be an Installing Officer. This is something that is between you and the Officer you choose.

REMINDER - POST/DISTRICT OFFICER CHANGES OR CORRECTIONS

<u>Headquarters immediately.</u> Changes in addresses, phone numbers and e-mail addresses should also be reported immediately - even if changes are made on the Online Membership System (OMS).

These changes are not always transmitted to State Headquarters; please help us keep our records current.

ELECTION AND INSTALLATION OF POST OFFICERS

Section 217 of the Constitution, By-Laws and Manual of Procedure, states that prior to the opening of nominations, the Post shall decide which form of election shall be used, unless the Post By-Laws specify the manner of election.

Any nominee shall have the opportunity to decline nomination for the office to which they have been nominated before nominations are closed. A member making the nomination of an absentee for any office shall have presented to the Adjutant, in writing, the consent of the member being nominated prior to the opening of nominations. Nominations of Post Officers shall open in March and remain open until the Post is ready to vote, provided, however, that when a poll system is used, nominations must be closed at the meeting prior to the election to allow the Adjutant to prepare a printed ballot.

Post officers shall be elected in April. Balloting for Post Officers may be conducted by open vote or written secret ballot (handwritten or printed) at a regular Post Meeting, or, if required by Post By-laws or authorized by Post vote prior to the opening of nominations, by a poll system and preprinted ballot. Absentee ballots and proxy votes are prohibited.

A majority vote of all votes cast, except where otherwise designated, shall be necessary to elect. If there be no election on the first ballot, the name of the comrade receiving the lowest number of votes shall be dropped and so on in successive ballots until an election is made.

If irregularities are claimed with respect to the election to any office, such challenge must be made in a writing containing specific details concerning the irregularities, signed by the challenger, and forwarded to the District Commander, mailed no later than three (3) days after the election.

Complete details regarding the election of Post, District, County Council and Department Officers are available in the 2024 Podium Edition of the National Constitution, By-Laws and Manual of Procedure. Every Post is urged to purchase a copy of the <u>Podium Edition</u> from the <u>VFW Store</u> for a nominal fee.

NATIONAL BY-LAW CHANGES REGARDING THE ELECTION OF OFFICERS

Officers at all levels should take note of Part 216 and 416 of the National By-Laws regarding the election of officers. Please also take the time to review your Post/District By-Laws.

Section 416 - Elected and Appointed officers; Chairmen and Committees.

(c) The District may elect or the District Commander may appoint a Judge Advocate, Surgeon, Chief of Staff or Officer of the Day if required by the District By-Laws.

Section 216 - Elected and Appointed officers; Chairmen and Committees.

(c) The Post may elect or the Post Commander may appoint a Judge Advocate, Surgeon, Officer of the Day and/or Guard if required by the Post By-Laws.

IMPORTANT NOTICE

Sec. 413 - Arrearages, Deficiencies and Omissions.

The Commander of the District in arrears for financial obligations to Department or National, for fees, dues, poppy money, supply money, or failing to have the office of the Quartermaster properly bonded in accordance with Section 703, failing to ensure that the District is properly insured in accordance with Section 709, failing to submit properly completed District Trustees Report of Audit, District Election Report for the ensuing year, or other obligations, shall be deprived of all representation at the Department Convention. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

A properly completed District Election Report shall be submitted to National Headquarters prior to the convening of the Department Convention. There is a blank election report at the end of these orders.

Sec. 212 - Defunct Posts

Any Post with less than ten (10) members, or while under suspension the Post fails to establish a meeting quorum or elect the required officers, its charter shall be revoked and declared defunct with the issuance of a special order by the Commander-in-Chief.

Disposition of Property. In all cases of surrender, revocation or forfeiture of a charter, title to all real and personal property shall immediately pass to the Department who shall take possession and control for disposition as directed by the Department Council of Administration for the purposes set forth in the Congressional Charter. In addition, the books and records of the Post shall be recovered by the Department.

In case of surrender or forfeiture of a charter, the Department Council of Administration in the case of trust funds or trust property, or both, shall carry out the intent and purpose of such trust to the extent of such funds or property, or both.

Sec. 213 - Arrearages, Deficiencies and Omissions.

Any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council and District meetings; County Council, District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

<u>Sec. 218 (K)- Duties of Commander (Attendance at District Meetings)</u>
Assure that the Commander or their representative attends all properly called District Conventions or meetings and County Council meetings (if applicable).

VOTING AT DISTRICT CONVENTIONS

Each member of a District Convention or District meeting are those persons as defined in Section 404 of the By-Laws, except delegates elected by the Posts, present at a District Convention or meeting shall be entitled to one vote. An individual possessing more than one qualification for membership in the District Convention or meeting shall have no more than one vote. The delegate or delegates of a Post present at a District Convention or meeting shall be entitled to vote the full delegate strength to which the Post is entitled.

Should there be a division among the delegates representing the Post, each delegate present shall cast his pro rata share of the total voting strength of the Post. For the purpose of this Section (Section 421-Voting), a Post Commander shall be considered a delegate.

A roll call vote may be required and entered upon the record at the call of any three

officers or delegates representing three different Posts.

This means that District Elections are determined not by the number of individuals present and voting but by the amount of weighted votes that each Post possesses

126th VFW NATIONAL CONVENTION

Columbus, OH, is the host city for the 126th VFW and 111th Auxiliary National Conventions, which will be held August 9- 13, 2025. Convention housing will open on March 17, 2025. We will release more information as we receive it.

VFW NATIONAL CONVENTION HOUSING

126th National Convention housing will open on Monday, March 17, 2025. Housing reservation information will be located on the convention website accessed through the main VFW website at vfw.org/convention. The convention website will also have general convention information, including the registration form and links to other convention-related information for Columbus, OH – August 9-13, 2025, and a tentative agenda.

NATIONAL CONVENTION REGISTRATION

Section 222 of the Manual of Procedure states each Post will pay, in advance, a National Convention Registration Fee of \$25 - which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Please note each additional delegate attending the National Convention will have to pay an additional \$10 delegate fee. Information on delegate registration will be available at a later date.

2026 ILLINOIS VFW CALENDAR

The Council of Administration voted in August to allow the State Headquarters to proceed with a 2026 calendar raffle as part of the Marketing Program. The raffle will begin on Jan. 1, 2026, and run daily through Dec. 31, 2026. The calendars will not be numbered to ensure the prizes are given away rather than to determine if the "winning"

calendar has been sold. Each calendar will cost \$20. Only 5,000 calendars will be sold. State Headquarters has created a prize structure and incentive package for Posts selling the calendars. Approximately \$21,500 in prizes will be awarded. Below is the prize structure

Incentive Program: To help State Headquarters sell the calendars, we have developed an incentive program in which each Post selling the calendars would receive \$2 for each calendar sold.

Sponsorship Programs: We have several sponsorships for posts, Auxiliary, and members.

Sponsor a Day—We have two levels of "Sponsor a Day" sponsorships. For Posts with 100 or fewer members, a day could be sponsored for a donation of \$25. For Posts with 101 or more members, a day could be sponsored for \$50.

In consideration of the sponsorship, the sponsor would be allowed to submit a photo or a tidbit of historical information for that day, which would be included. The photo or information would not have to be about that day. Example: A Post could sponsor their anniversary day, including a photo of their post, the Post's namesake, or information about their post namesake.

Sponsor a Week – For \$250, the entire week (Sunday-Saturday) could be sponsored. In consideration of the sponsorship, the sponsor could place three photos and four tidbits of historical information.

Sponsor a Month – For \$1,000, the entire month can be sponsored. In consideration of the sponsorship, the sponsor would be allowed to include a display photo (the main photo for that calendar month) as well as additional photos and informational tidbits throughout the month (to be placed on unsponsored days).

Calendars will be printed and available at the Illinois VFW State Convention in June. If your post (or members) is interested in sponsoring a day, week, or month, please let State Headquarters know. We'll work with the sponsors to ensure their photos and/or information is included on their sponsored area(s).

PEACE OFFICERS MEMORIAL DAY, MAY 15TH

Posts within the Department of Illinois are hereby instructed to fly their U.S. Flag at "half-staff' on May 15th, 2025 in observance of **Peace Officers Memorial Day, May 15**th as authorized by Public Law 103-122. (See law below):

175. Position and manner of display

The flag, when carried in a procession with another flag or flags, should be either on the marching right; that is, the flag's own right, or, if there is a line of other flags, in front of the center of that line.

(A)-(1) (Unchanged)

(iii) The flag, when flown at half-staff, should be first hoisted to the peak for an instant and then lowered to the half-staff position. The flag should be again raised to the peak before it is lowered for the day. On Memorial Day the flag should be displayed at half- staff until noon only, then raised to the top of the staff. By order of

the President, the flag shall be flown at half-staff upon the death of principal figures of the United States Government and the Governor of a State, territory, or possession as a mark of respect to their memory. In the event of the death of other officials or foreign dignitaries, the flag is to be displayed at half-staff according to Presidential instructions or orders, or in accordance with recognized customs or practices not inconsistent with law. In the event of the death of a present or former official of the government of any State, territory, or possession of the United States, that Governor of that State, territory, or possession may proclaim that the National flag shall be flown at half-staff.

The flag shall be flown at half-staff thirty days from the death of a President or a former President, ten days from the day of death of the Vice President, the Chief Justice or a retired Chief Justice of the United States, or the Speaker of the House of Representatives; from the day of death until interment of an Associate Justice of the Supreme Court, a Secretary of an executive or military department, a former Vice President, or the Governor of a State, territory, or possession; and on the day of death

- Your poppies should be ordered 6 to 8 weeks before your distribution. State Headquarters does have Poppies in stock. A shipping charge will be added to the invoice for orders shipped from this office. **Please order early!**
- Poppies must be ordered using a name. Your order will be shipped to the name of the person who ordered them, but not to "VFW Post __ " or just "Commander" or "Quartermaster".
- Please include a street address. Poppies are shipped via UPS or Fedex and

cannot be delivered to a Post Office Box.

- Poppies can be paid for by check or by credit card. <u>Please submit payment with your order or pay promptly when invoiced.</u>
- Be sure to put an actual sale date on your order.
- Poppy cans, caps, table covers, vests, aprons, etc. are ordered directly from the <u>VFW Store</u> at National Headquarters.






