Illinois Day begins with ceremony at cemetery, playground dedication at National Home

The annual Illinois Day at the VFW National Home in Eaton Rapids, Michigan, Sept. 23 began with a brief remembrance ceremony at a local cemetery to remember the life of an Army Soldier Killed in Action in Vietnam.

The ceremony concluded with Commander Brett Nila and President Lynn Smith placing a memorial wreath at the base of the flagpole.

Following the ceremony, the Illinois VFW and Auxiliary members traveled to the National Home. The events at the National Home began with the dedication of new playground equipment - purchased with funds raised by the Illinois VFW and Auxiliary.

During the afternoon silver march, more than \$85,000 was donated to the home.

Throughout the late summer and fall, many Posts and Districts have remained busy, performing the VFW mission of fostering camaraderie, advocating, and serving veterans, the military and our communities. Your Department has been active as well.

The August Council of Administration (C of A) meeting was held in Naperville. Among the typical reports given, three newly appointed officers were on hand to make their reports. Maurice Theriac, the new MOC (Military Order of Cooties) Coordinator, noted his availability to help those interested in standing up new Cootie Pup Tents. Anthony Bellin, the new VFW Riders Liaison, addressed his plan to gather information on various Rider groups, and be a resource for those seeking Riders to support events. Doug Jameson, the new VAC (Veterans Assistance Commission) Liaison, stressed the need for Posts with VACs in their County, to provide their delegate to every VAC meeting.

Also during that meeting, the Council voted to change the location of the Department Convention for the next two years. Convention meetings and dining events will now be conducted at the Springfield Convention Center, located across the street from the Wyndham Hotel and next door to the Abraham Lincoln Hotel. Lodging will be divided between the Wyndham and the Abraham Lincoln. This change was made to offset the significantly rising cost of food and beverages at the hotel. While the Wyndham provided free meeting space, it required purchase of Wyndham food and beverages, with no other options. But while the Convention Center charges for meeting room rental, it also provides a wide choice of caterers that are far more competitively priced. As a result, the Convention Center's total cost for meeting rooms, food and beverage is notably less and offers more menu options than the Wyndham's higher cost for food and beverage alone.

While still early in the year, our Department has done some notable fund-raising. On September 9th, Pier 55 Lounge in Springfield raised \$5,000 for this year's Commander's Spe-

cial Project - the five Illinois Veterans Homes. On September 10, the annual VMS (Veterans & Military Service) Jeep Run raised \$1,000 to support the VFW Unmet Needs Program.

On September 23rd, Illinois Day at the National Home, the Silver March collected over \$85,000. Also that day, a new playground was dedicated. Last February, the Auxiliary proposed partnering with Department to fund a new playground. Many Posts began submitting donations before the end of the 2022-23 year and by September 2023, over \$19,000 had been donated from our Department. The Todd Marriott Memorial Playground was dedicated that day to honor the long-time Facilities Director who passed away this past summer.

As of November 1st, a Joint VFW and Auxiliary effort raised over \$4,175 for Hawaii relief. These donations were collected and forwarded through the Illinois VFW Foundation, our 501(c)(3) non-profit arm. At the August C of A meeting, it was decided that engaging the Foundation in support of such efforts would be the most efficient way to administer them while also providing an ongoing charitable function for the Foundation.

A new, though much smaller fund-raising effort, involves the rank bars for the VFW Membership badges; they can now be purchased for \$15. Profits will go to Department funding.

Until recently, rank bars were only available for District Commanders and certain Department Officers. Now they're available for Post Commanders, Past Post Commanders, and Past District Commanders as well. As of this writing, 45 have been sold so far. If sales continue, the selection will be broadened to include other officer positions as well. Complete information on purchasing the rank bars can be found on the Department website, via a link at the bottom of the home page (near the link to "Commander's shirts"). They will also be on hand for sale during the February 9 - 11 Council of Administration meeting at the Crowne Plaza in Springfield.

During September and October, four of the five Commander's Calls were conducted at four different locations, two in the northern part of the state and two in the southern part. This year, more training was incorporated. Adjutant/QM Joe Bartley explained the new Department Dashboard-now showing every All-State requirement-and how it was re-designed based upon input from the field; he also cited specifics on how to most efficiently use it to report details on activities. Membership Chairman John McGlynn covered Online Membership System (OMS) operation. Both he and Assistant Membership Chairman "Skip" Skipper, who joined in the southern seasons, addressed their ability to provide

lists of unpaid, at-large and expired members upon request. Auxiliary member Tara Skipper has been working as part of the Membership Team and addressed how social media can be used to augment our recruiting efforts. Department Chief of Staff Rob Bailey was on hand to answer questions concerning Inspections. My portion addressed the importance of all members knowing the VFW Mission Statement and how that, along with Core Values, can foster a culture within a Post or District that produces a positive environment that members will enjoy and want to be a part of. I also covered a Retention program focused on "onboarding' new members, getting members involved, training and mentoring, and recognizing members' efforts. Group exercises (similar to Steve Macinnes "edutainment" exercises at last June's state convention) gave attendees a chance to interact and share some of their "best practices" in response to different questions for each group. These best practices will be organized and disseminated before the end of this year.

In late October, we hosted the VFW Big Ten Conference at the Westin Hotel in Itasca. The Big Ten is one of four VFW regional bodies that take turns selecting the Junior-Vice Commander-in-Chief designee each year; that person is subsequently elected National Junior-Vice Commander-in-Chief at the following summer's National

Since the September 2023 Illinois VFW Newspaper edition, I have attended the August Council of Administration meeting held in Naperville, Illinois Day at the National Home in Eaton Rapids, Michigan, District 14 Training, several District meetings, Caseyville Post 1117 85th Anniversary, Commanders Call in Marshall and Collinsville, Membership Dinner at Highland Post 5694, The Scott POW/MIA Council Program at Post 805, Veterans Day Speaker for Post 3480 and more. As you can see, I am working hard for you representing the Department of Illinois. In addition to travelling throughout the State of Illinois, the Department Leadership Team, under the leadership of Brett Nila, meets every other Friday at Department Headquarters in Springfield. At our meetings, we plan for future events, track and discuss membership challenges, and brainstorm issues that arises.

four VFW conferences nationally that serve as an informal intermediary between VFW National and the Departments around the country. A primary function of these conferences is to be a mechanism for selection and nominations for National Officers, streamlining the election process at the National Convention in an organized and clear way.

There are four conferences that divide up the VFW nationwide. They are the Western, Eastern, Southern, Southern and Big Ten Conferences. The Big Ten is made up of the following VFW Departments: Michigan, Ohio, Indiana, Illinois, Missouri, Nebraska, Iowa, Minnesota, South Dakota and Wisconsin. Every autumn, the four VFW conferences gather separately to elect their conference leadership, and educate Department leadership of VFW National programs. Each conference will nominate a leader to serve in a position VFW National, either at their annual conference or at the VFW National Convention. Four National positions for nomination rotate between the conferences every four years, allowing each conference to nominate a new position yearly. Positions on this rotation are VFW National Surgeon, Judge Advocate, Chaplain, and Junior Vice Commander.

The new Dashboard display colors are red and green. The color red lets you know the requirement for that program has not been completed. A new change this year with the Dashboard is that there are two Dashboards, one for the Districts and one for the Posts. It is important that the Post knows that they are responsible for inputting the first five Pillars at the Post level. The five Pillars that the post is responsible for are as follows: Community Service, Veterans Assistance, Youth, Legislative and Illinois Specific. The other Pillars can only be turned green by the Department. The following Pillars must be reported to the Department: Program Nominations, Program Donations, Meeting Attendance, Audits, Bond and Inspections. So, lets continue reporting all that we do in the Community, providing Veterans Assistance, mentoring and support our youth. I get a lot of questions concerning deadline dates. For example, what is the deadline date for the Voice of Democracy and Patriot's Pen applications to be turned into the District, Scout entries to the Post, etc. All program deadline dates can be found at vfwil.org under the resources tab, Commanders Leadership Manual and Important Dates and Deadlines.

from the State of Illinois visited the VFW National Home. The State donated more than \$85,000 to the National Home. Outstanding job!! The VFW National Home assists military servicemembers or veterans and their families facing a wide variety of challenges, such as reintegration after military discharge, post-traumatic stress, homelessness, rehabilitation from battlefield injuries, and unemployment. In October, the Department held its first Council of Administration (C of A) meeting of this fiscal year. At this meeting, a lot of information was provided to District Commanders. District Commanders must pass on the information provided from the C of A at their District meetings and Post Commanders must ensure to pass on the information at their Post meetings. In addition, at this C of A meeting, we had two speakers from two organizations, the Illinois Attorney General's office and Illinois Joining Forces.

State Junior Vice Commander

Greetings fellow Comrades. While attending the Junior Vice Commander Conference and touring the VFW National Headquarters, I was very surprised to learn about its history. It first opened in Pittsburgh, PA, in 1914 and, in 1918, it moved to Union Square in New York City. The move to Union Square was near the end of the Great War and our membership grew from 5,000 to 64,000 during a five-year period – a twelvefold increase.

In 1923, the VFW decided to expand membership westward and southward so it relocated the headquarters to Kansas City, KS. At that time, Kansas City serviced 32 railroad lines, making traveling to its location easier. In 1930, the VFW moved to Broadway and 34th Street in Kansas City, MO where it sits today. The building was previously a medical treatment center with doctors' offices before housing the VFW. Today our VFW continues to modernize to meet the needs of Veterans across the nation.

We are divided into four conferences (Big Ten, Eastern, Western, and Southern) and we now have membership totaling approximately 817,000. Just think, in the five years after the end of the Great War, our membership increased over twelvefold and focused mainly on the East and Mid-West. Currently, we focus on four conferences. With technology and modernization, we should be able to increase membership by at least one-half and increase sixfold. That would place our membership at approximately five million over the same fiveyear time period. Just think, five million VFW members voicing our problems and concerns to Congress to ensure that all Veterans obtain all the benefits earned. Just a thought!

As we prepare for the cold weather, snow, wind, and inclement weather, we celebrated Veterans Day on November 11.

This is a time to reflect on where we are now, where we will be in the future and remember those that never returned home. I hope each of you took the time to celebrate Veterans Day with passion and enjoyed all the freebies and discounts offered to us during this time. It's also a good time to learn more about National Veterans Day Ceremonies and other Veterans Day information at https://department.va.gov/veterans-day/.

Convention. The Big Ten holds its conference every October, hosted by a different one of the ten member states each year. The last time Illinois hosted was in 2013. Feedback on this year's event has been positive. A new feature that was well-received, was hosting the Friday evening "mixer" at a local Post, with nearby Post #2149 in Wood Dale opening its doors exclusively to conference attendees. During the business session the following day, the Big Ten elected a new Vice-Chairman and a Chaplain. By-Laws were also amended, which included elimination of the requirement for the hosting state to provide almost \$3,000 in complementary registrations to the Conference leadership, beginning next year. I want to thank the volunteers who were on hand along with the full-time staff who were there to ensure the operation ran smoothly. And a special "thank you" to the Planning Committee of John Davin, Barb Wilson and Chuck Ingle, who started the site selection process with me back in September 2021; they too were on hand to see this journey through to a successful completion. Also in late October, our State Service Officer, Derek Giffin, left our employ to take a position with the VA. We certainly want to thank Derek for his years of service to the Illinois VFW and wish him success in his new position. With Derek's departure, we now have two Service Officer positions to fill. That includes the role of State Service Officer which will ultimately be determined by our Veterans

Service Committee. At the same time, we're also reviewing the positioning of our service officers throughout the state.

At the end of October, our Membership Team began a Facebook campaign to connect with Posts. Through that connection, more Posts learned about acquiring lists of expired, unpaid, and relocated members, as well as members-at-large, targeted to the zip codes they request. Many Posts have made contacts and gained new members from these lists. If we're to reach 102% in strength, we need to employ every strategy to grow our membership. Those who haven't obtained their lists can reach out to John McGlynn or "Skip" Skipper, or just contact Department Headquarters.

With the start of November, many Posts are selecting their Voice of Democracy (VOD) and Patriot's Pen winners. Districts meanwhile are preparing to select their winners and planning their awards functions. The Department VOD and Patriot's Pen Banquet will be on Saturday evening, February 10 in Springfield at the Crowne Plaza Hotel. Ticket prices will be \$45 per person. The sky-rocketing hotel menu prices—which we also experienced at the state convention and at the Big Ten Conference—have necessitated this increase. Watch for more details in the General Orders. As I said at the start, there's a lot going on at Department. And I know there's a great deal going on in the field, so I encourage

Kahokian Memorial Post hosts PACT Act Resource Fair

On Sept. 26, Kahokian Memorial VFW Post 5691, Collinsville, held a successful PACT Act Event/Resource Fair, organized by Senior Vice Commander and acting Post Commander Andy Frisby, a U.S. Air Force veteran of Operations Desert Shield and Desert Storm.

Frisby organized the event ahead of the Sept. 30 deadline for all veterans who were deployed to combat zones, regardless of VFW membership, and their families to get signed up for health care enrollment and have other questions handled in person without having to drive or get a ride to St. Louis. His original plan was to organize a Stand Down at Post 5691, but it did not pan out. Marcena Gunther, Public Affairs and Volunteer Services Director for the St. Louis Veterans Administration suggested the resource fair instead

This fair was the first of its kind in the Metro East that is covered by the St. Louis VA, which covers Madison and St. Clair Counties. Veterans or their family members were even able to have their DD-214 printed off to prove their military credentials for services.

Gunther and Lulu Liang, center for development and civic engagement specialist with the St. Louis VA served as liaisons with the St. Louis VA. Twelve departments were available to answer questions and help Veterans or their family members sign up for benefits including: augural event included a US Navy veteran who was able to speak to a VA disability processor at the fair regarding her open claim she believed was able to access the claim, saw what was causing the problem, corrected the

The event was successful, with nearly 40 claims being filed by participants, as well as assistance given to veterans who had filed but had issues with their applications. Most of the veterans that filed claims at the event have already had their compensation and pension meetings with outside providers set.

One example of a success story from this in-

a US Navy veteran who was able to speak to a VA disability processor at the fair regarding her open claim she believed was stuck. The processor was able to access the claim, saw what was causing the problem, corrected the problem, and the veteran reports that she now has forward movement on the claim. Another success story comes from another US Navy veteran with a claim the VA was requesting a duplicate of medical records from the primary doctor that had already been sent but had now misspelled the doctor's name. The claims processor was able to delete the duplicate request and forward movement has now been made on the veteran's disability request.

Frisby is planning on permanently holding the event at the Kahokian Memorial VFW Post 5691 so the local veterans community can attend the event two- or three-times next year and growing the event to include more veterans service organizations, both governmental agencies and private sector and transportation for homeless veterans in the area.



Flag Day Monument dedicated in Batavia

On October 1, 2023, at 2 pm, American patriots gathered in Batavia, IL to honor a local and National hero on his 157th birthday as well as unveil a monument to the American Flag and the rich history it stands for.

Dr. Bernard Cigrand (October 1, 1866 – May 16, 1932) Born in Waubeka, Wisconsin, Cigrand practiced dentistry in Chicago, Batavia, and Aurora; but that is not what he is most known for, Dr. Cigrand is known as the "Father of Flag Day." From the late 1880s on, Cigrand spoke around the country promoting patriotism, respect for the flag, and the need for the annual observance of a Flag Day on June 14, the day in 1777 that the Continental Congress adopted the Stars and Stripes.

He became president of the American Flag Day Association and later of the National Flag Day Society, which allowed him to promote his cause with organizational backing. Cigrand once noted he had given 2,188 speeches on patriotism and the flag. In June 1886, he first publicly proposed an annual observance of the birth of the United States flag in an article titled "The Fourteenth of June," published in the Chicago Argus newspaper.

After 30 years of Cigrand's advocacy, to include writing letters to seven sitting US Presidents on the subject, President Woodrow Wilson proclaimed June 14 as Flag Day in 1916. Congress would eventually make the proclamation law in August 1949.

The Flag Day Monument, a project that started as a con-

versation in 2016 (the 100th anniversary of Flag Day) about how to celebrate Flag Day every day, is a tribute to the American Flag, and so much more.

The flag tells the story of our nation's history. It celebrates the arrival of new states, is lowered to honor our dead, and it marks noteworthy events in time.

The monument unfolds our nation's history beginning in 1776 and continuing into the future, marked by 25-year increments. The design features a 40' diameter helix monument with a 6' wide walkway around the perimeter. The flagpole is 50' tall and will display a 10' x 18' flag.

The next phase is to create an educational station on the outside of the main structure, this will be where youth and civic groups can come and learn about America's history and the monument prior to entering. The monument is still in need of funding for future plaques, benches, and routine maintenance. Please consider donating through the purchase of a brick on the entry walk into the monument. Bricks can be bought by going to www. flagdaymonument.com, it would be nice to see the walkway overflow with VFW bricks.

The Fox Valley Patriotic Organization (FVPO), who was responsible for the construction of the monument, was joined by local residents, Veterans Organizations (most notably Batavia Overseas Post 1197), the Daughters of the American Revolution, the Sons of the American Revolution, the Batavia Community Band and so many more for the unveiling of the monument.

Medal of Honor Recipient and Emeritus FVPO Board Member, Allen J. Lynch, was the guest speaker at the dedication and gave a rousing speech on patriotism, the flag, and our future as a country.

The Ceremony was outstanding, the weather was perfect, and it was great to see so many patriotic Americans celebrate their Flag. Since the monument was made with the intent that more content could be added to it, I will leave you with this quote from the last plaque on the helix. "The future is yours... it is yours to decide the culture we embrace, the peace we achieve, and whether our nation grows or diminishes."

Belvidere honors Marine veteran killed in action in Vietnam

On Aug. 12, Vietnam War veteran Jeff Smith who was killed in action, was honored by his hometown of Belvidere for his sacrifice and his service.

The ceremony, arranged by Belvidere Mayor Clint Morris, took place at the Belvidere Veterans of Foreign Wars, Post 1461 with close to 100 people attending along with members of Smith's family.

Jeff Smith was the only known Belvidere, Illinois resident to have died while serving in Vietnam.

"I want to say thank you to everyone who came out today," stated Smith's older brother Jedwin while speaking at the ceremony. "Our family is greatly honored. I'm speechless."

Jedwin Smith is a former Marine who served in Vietnam himself. He authored the book "Our Brother's Keeper" about the death of his younger brother Jeff and the devastating impact it had on his family.

Jedwin recalled that his Avenue. brother Jeff put aside his anti-war sentiments and joined the Marines in July of 1967 much to his family's surprise. 4 months later he was sent to Vietnam to serve in the infantry as a member of Foxtrot Company, 2nd Battalion, 4th Marine Regiment, 3rd Marine Division.

On March 7th, 1968, while on patrol near the village of Mai Xa Thi in the Quang Tri Province of South Vietnam, Jeff Smith was killed during an ambush by the Viet Cong.

"Jeff is my best friend and has been since that horrible day in Vietnam," Jedwin Smith declared. "55 years ago Jeff died but he'll live forever in mv heart."

Belvidere Mayor Clint Morris came up with the idea for memorializing Jeff Smith and helped arrange the ceremony.

A major part of the memorial was renaming one of the major streets in Belvidere from Logan Avenue to Jeff Smith Memorial

"Vietnam veterans as we know were not welcomed home on their return very graciously," pointed out Mayor Morris after the ceremony. "I always thought that was wrong. And Jeff was certainly one of the 58,318 service members who lost their life and I thought we should memorialize him, and so we have.

After the ceremony Jedwin Smith commented on how he and his family were thankful to Mayor Morris and the entire Belvidere Community for the ceremony honoring Jeff, and that it would help the family to heal emotionally. He added his brother would have been surprised by all the attention.

"Jeff would be smiling from ear to ear. He didn't have an ego. He'd be tickled but he'd also be saying what's the big deal? I know he would have been honored."

Oswego dedicates road in memory of Luckinbill

The ceremony to dedicate a portion of Route 30 in Oswego as Herschel Luckinbill Road in memory of the late U.S. Navy veteran was held Oct. 13 at Route 30 and Douglas Road in Oswego.

"Herschel's unwavering dedication to his country, his fellow veterans and our community is an inspiration to us all," said state Rep. Stephanie Kifowit, D-Oswego, in a press release about the ceremony. "As we dedicate Herschel Luckinbill Road we ensure that his legacy lives on for generations to come, a reminder of the profound impact one individual can have."

Earlier this year, the Illinois General Assembly unanimously passed House Joint Resolution 79 to designate a section of Route 30 in Kendall County in memory of Luckinbill, a former Montgomery resident and longtime advocate for Fox Valley

"Herschel Luckinbill was my best friend," said Roosevelt-Aurora American Legion Post 84 Cmdr. Mike Eckburg in the re-

paths and then ran together with each other at countless events and activities, all veteran-related, for 15 to 20 years. I'll never meet another one like him. It's very appropriate that he is recognized. He was a good family man, a patriot and an American hero."

"Herschel was a proud veteran." remembered Rick Gardner, co-leader of the Fox Valley Veterans Breakfast Club.

During his military service, Luckinbill served in the Vietnam War aboard the USS O'Brien, a destroyer, completing two tours of duty. Two days before Christmas in 1966 his ship was hit by direct fire from the North Vietnamese.

As the general quarters alarm was sounded and he and his shipmates poured out of the sleeping compartment, 19-yearold Luckinbill got topside just as an incoming shell hit, killing two of his friends right behind him and wounding four more.

Luckinhill dedicated the last decades of his life to promoting

lease. "I'm thankful we crossed veterans' causes in memory of those who did not make it home, according to the release.

He served as a guardian to veterans for Honor Flight Chicago 25 times, escorting them to Washington, D.C., to visit the memorials there. In addition to his work with Honor Flight Chicago, he was instrumental in bringing the Vietnam Moving Wall to Aurora and Oswego, as well as the Middle East Conflicts Wall to Oswego, officials said.

In 2008, he took on the leadership of the Fox Valley Veterans Breakfast Club. He alsc actively participated in numerous youth sports and area organizations, officials said

"Herschel was a tremendous community leader who dedicated his time and talent tc serving veterans throughout our area,' said Oswego Village President Ryan Kauffman. "His steadfast commitment to improving the lives of others was truly remarkable and this road dedication will remind us of his legacy."

Logan Avenue in Belvidere was renamed the Jeff Smith **Memorial Avenue.**

The Member of the Year- I know we all know someone who goes above and beyond. They never stop working for our Veterans. Please be sure to get you nominations to Barb Howard.




The Illinois Auxiliary partnered with the Illinois VFW to fund the project, an effort that State Commander Brett Nila said came easily.
